Community Arts Council Report Heritage Commission Wednesday December 4th Alberni Valley Museum

1. Gallery - On at the gallery is the annual Mistletoe Market on until December 23

-This year we have several new artists and crafters

- Along with the market, we also have a silent auction of several arts pieces, and we will have tickets for our 2 baskets

- the gallery is open late on Friday and Saturday, and this Friday and Saturday, December 6th and 7th, members only special discount of 20% on all items in the gift shop

2. Light up at the Quay went off without a hitch. Even the weather cooperated. And the tree lit up on cue at the end of the countdown.

-performers included the ADSS Christmas band and a mixture of the Barclay Sound Community Band, Timbre! Choir, and the Urban Street Choir.

- The event was sponsored by the CAC, Salmonberries and the Donut Shop.

3. The CAC is very excited to have applied for and received a grant of \$30,000 from the B.C. Arts Council for arts leadership training for an executive administrative assistant. B. School District

Pacific Rim SD Heritage Commission report Dec 4, 2024

The next Public Board Meting is Dec 10 at 5pm at Tsuma-as Elementary.

- 1. ADSS Band is playing at many seasonal events. Concert dates are Dec 10 and Dec 11 at ADSS.
- 2. Preparations for Totem Tournament are underway for Jan 9, 10, & 11, 2025.
- 3. New name for Sports Teams at ADSS is "Wilgsii"/ Storm/.
- 4. Recent water testing in Pacific Rim to determine lead levels. The safe level is 0.005 mg/L as set by Health Canada. All schools continue to have multiple unaffected tap locations available for drinking water. As recommended by Island Environmental Health and Safety Ltd in most tap locations, the implementation of daily flushing program is sufficient to reliably reduce the concentration of lead below accessible levels. The district also has installed a few years ago inline filtration systems. We are presently installing more filtration systems where necessary. Signage has been placed at all affected taps. The district has contracted island EHS to conduct immediate testing across all district facilities that have not already been tested as part of the regular requirements. The ordinary course of testing is 1/3 of schools in the district tested each year on a rotating basis. We will have a 'new page' poste to the district website with the annual testing results.
- 5. The Winter Break is from Dec 23 Jan 6 2025.

McLean Mill National Historic Site Update, Dec 3rd, 2024 Prepared by Elliot Drew

With the conclusion of the One Mile project and subsequent reopening of the Site on Nov 1° we have returned, more or less, to business as usual for this time of year. While most of our year end data crunching has been completed and preliminary budgets done for 2025, there is still a lot of planning work to accomplish over the next few months.

Our last booking for 2024 took place on Nov 3rd with the Alberni Bowmen holding their One Day shoot. This will be our final event this year as we have no holiday bookings. As such we have put the Site into its winter storage state and have moved operations back to the Chamber office at the Visitor Center. For anyone looking for McLean Mill Merch for the Holidays it is now available at the Visitor Center Gift Shop.

We presented to Council at the COW on Nov 18th to update them on our activities and ask for a clear long-term vision of the Site to better align our plans and policies for the future. We also committed to providing an operations plan for the 2025 season by January 31, 2025, as long as we are provided that vision. I also was thrilled to have my first meeting with Manager of Culture Shella Perry and Kirsten Smith from the Museum to tour the Site and begin the discussion of how we can best work together to share this amazing piece of history with visitors.

The Cyclone Bomb that wreaked havoc out in Beaver Creek also had a major impact on the Site with multiple trees felled, power lines down and a forests worth of debris scattered everywhere. Luckly no damage was done to any historic assets. A huge thank you to city staff and contractors who rushed immediately to take care of things and our grounds team from PAACL who are doing clean up.

We continue to field booking requests for 2025 and 2026. They are slowing with the approach of the holidays, but we now have 10 weddings on the books for next season. We are hoping to add a couple more in the new year.

2024 has been a busy, productive and eye-opening year. An opportunity to truly start to see the real potential of our operations at the Mill and we are excited by what the future has instore for us. It is our hope that the hard work we have done to lay the foundation of a solid business model will be able to be built upon in the coming years to see this amazing destination thrill and inform visitors as it approaches it 100th Birthday.

"City of Port Alberni 2024-2028 Financial Plan Amendment Bylaw No. 5097-1, 2024" was introduced and given three readings. The amendment is provided to consolidate all changes made through Council resolution in 2024 within the 2024 – 2028 Five Year Financial Plan. Council will consider adoption at their December 9th Regular meeting.

"Fire Control Bylaw No. 5122, 2024" was

introduced and given three readings. The Fire Control Bylaw grants authority to the Fire Chief and other members of the Port Alberni Fire Department (PAFD), indemnifies members of the PAFD, specifies the services provided, and sets out rules for residents, owners and developers pertaining to fire safety.

"Nuisance Abatement Bylaw No. 4705-3, 2024"

was introduced and given three readings. Upon adoption this bylaw will reflect current language for the definitions, warding about prohibition on both private and public places, and an updated fee schedule.

CORRESPONDENCE

Alberni-Clayoquot Regional District | Grant Opportunity

Council directed staff to provide approval for the Alberni-Clayoquat Regional District (ACRD) to apply for the Union of BC Municipalities Community Emergency Preparedness Fund for the Emergency Support Services Equipment and Training Grant and authorizes the ACRD to apply for, receive, and manage grant funding on behalf of the City of Port Alberni.

Ministry of Environment and Climate Change Strategy | Five-Year Bear Smart Renewal Review

Council received the Five-Year Bear Smart Renewal Review dated October 7, 2024 from the Ministry of Environment and Climate Change Strategy.

NEW BUSINESS

Flag Policy

Council rescinded the Flag Policy dated May 9, 2011. This policy has been updated and approved under the Chief Administrative Officer to provide direction and guidance to City staff in the display of flags inside and outside City facilities and at City ceremonies in conformance with accepted national protocols.

Echo Aquatic Centre Operations

Council postponed consideration to amend the 2025 Financial Plan to include \$110,000 in Aquatic Centre wages to facilitate daily operation of the Aquatic Centre in 2025 to permit staff to provide additional information at the December 9th Regular meeting.

Echo Aquatic Centre

Council has postpaned the proposed motion to remove maintenance and upgrade projects for the Echo Aquatic Centre from the 2025-2030 Financial Plan, permitting only essential safetyrelated maintenance until a critical failure occurs or a decision on the new facility is made to a future Committee of the Whole Financial Plan meeting, allowing staff to gather more information.

3250 9h Avenue

Council directed staff to prepare a report outlining the history of the old civic complex at 3250 9th Avenue, along with potential options for Council to consider, aimed at minimizing fiscal investment in the building.

Multiplex Rink Board Replacement

Council directed staff to proceed with issuing a request for proposals for the following infrastructure on the Primary Sheet

(Weyerhaeuser) at the Alberni Valley Multiplex in the spring of 2025:

- Replace all rink (dasher) boards and kick plates
- Replace all acrylic glass and fasteners on the front of rink boards
- Replace all perimeter glass 5' in height to 6' in height and install corresponding stanchions
- Install a custom double door at the corner adjacent to the home team's bench
- Clean perimeter vertical glass to like-new condition
- Re-certification of all components by the contractor who installed the original rink boards

Recognition of Service Policy

Council rescinded the Recognition of Service Policy dated September 30, 2008 and approved the updated Recognition of Service Policy No. 3002-7. The policy speaks to recognition of employees when they have achieved 10 years of continuous service with the City and at every subsequent 10 years of service, as well as upon reaching the milestone of 25 years of service. It also provides recognition to employees upon their retirement from the City.

3rd Quarter | 2024 Procurement Summary

Council received an update/report on procurement contract awards and social procurement activities for the 3rd quarter.

MMBC Recycling Inc. Master Service Agreement

Council authorized the Mayor and Corporate Officer to enter into the Master Services Agreement with MMBC Recycling Inc., for a fiveyear term beginning January 1, 2025 and expiring December 31, 2029 for the purpose of collecting curbside recycling materials within the City.

Appointment of Deputy Corporate Officer Council appointed Kim Motiuk, Deputy Director of Corporate Services, as Deputy Corporate Officer, to fulfill the responsibility of corporate administration in accordance with s. 148 of the Community Charter for the City of Port Alberni during vacation, leaves or other absences of the appointed Corporate Officer effective November 25, 2024.

Highlights from the Alberni-Clayoquot Regional District (ACRD) **Board of Directors Meetings - September 2024**

SEPTEMBER 11 AND 25 MEETINGS

INCLUSIVE REGIONAL GOVERNANCE

The Directors received the ACRD Inclusive Regional Governance Orientation Guide which is a living document that provides an overview of the Inclusive Regional Governance Initiative, background on the process of Treaty First Nations joining the ACRD and highlights the different governance systems and processes in the region (ACRD, Treaty and non-Treaty First Nations).

SURVEILLANCE POLICY

ACRD Surveillance Policy was adopted by the Board of Directors, and a motion was passed to direct staff to conduct a review of current surveillance systems being used in the ACRD and ensure they are in compliance with the policy.

SOLID WASTE MANAGEMENT PLAN ENGAGEMENT

The Solid Waste Management Plan Update and Engagement Plan was referred to an Electoral Area Directors Committee meeting held on September 24, 2024.

UBCM FUNDING APPLICATION MOVES FORWARD

Support was provided for the UBCM funding application to the Community-to-Community Program for the development of Equitable Employment policies and programs at the ACRD.

PARTNERING IN FIRE SUPPRESSION

Huu-ay-aht Government and ACRD Fire Suppression and First Responder Service Agreement was finalized for the Bamfield Volunteer Fire Department to provide this service to Anacla/Grappler Inlet for five years.
