Location of Alleged Offence: Argyle Street from Harbour Quay to 3rd Avenue Date of Alleged Offence: July 6, 2024 Description of Complaint: Bylaw 4718-4804 states at length about disturbances to the quiet, peace, rest, enjoyment, etc of any person. The intersection

of Argyle and Kingsway has three fairly large apartment complexes containing a lot of people who cannot have the peace and quiet mentioned above due to the daily, hourly noise from customized cars and trucks along with the motorcycles, some of which are also customized. The problem results because for their enjoyment they slow down as they approach the intersection and then "give it all they've got". Beyond any kind of bearable noise. Within the last two-three weeks there have been two episodes of a very large group of motorcycles speeding up Argyle from the Quay. One loud motorcycle is enough. Then there's the speed involved. I have been sitting in my living

room and have been disturbed. It's not just when on my deck. Is it possible to install one of those low impact speed bumps just east of the alley that crosses Argyle mid 5200 block? I am sending you this knowing full well you have perhaps larger fish to fry but this has become a problem disturbing peoples lives. I had to designate a month so I just chose July but believe me it's April to October. Thank you for reading.

#### Introduction

The purpose of this communication is to address the impact on Compton Road from Margaret Street to Grandview Road within the City of Port Alberni. This communication is requested in conjunction with the planned roundabout on River Road at Beaver Creek Road in an effort to divert traffic from the community of Beaver Creek down to River Road (Highway 4). Currently, high volumes of traffic use Compton Road as a cut through as it is currently difficult to make the left turn from Beaver Creek Road to River Road. When the planned roundabout is completed, it is this submission that traffic should be diverted to River Road thus less impact on Compton Road through the school zone at Tsumas-as Elementary School.

#### Issues

- 1. Speeding in the 30 km/hr zone school days from 8:00 am to 5:00 pm. Compliance with school zone speed limits is almost nonexistent unless the traffic volume is heavy.
- Speeding in the 50 km/hr zone outside of school days. Many evenings and weekends there is an issue
  with street racing and excessive speed along Compton Road as it is a long stretch of road with no
  obstructions.
- 3. Volume of traffic on Compton Road (mostly from the Community of Beaver Creek). Once the roundabout at Beaver Creek Road at River Road is complete, there is no reason for commuters to use Compton Road to cut through residential areas.
- 4. Volume of large commercial vehicles is a major issue. Every hour, there are loaded logging trucks, fuel tankers and large commercial vehicles that use Compton Road to avoid the current difficult left turn at River Road. Although understandable, once the roundabout is complete, no commercial vehicles should be using Compton Road.
- 5. Other notable Motor Vehicle Act Offenses such as Distracted Driving.

#### Recommendations

- 1. Speed Hump with marked crosswalk where the current crosswalk is located on Compton Road at Margaret Street. This will slow traffic and allow safe crossing by students during school hours and the general public any hour. (See attached picture)
- 2. Speed Hump with marked crosswalk where the current bus stop is located at the front doors to the elementary school. (See attached picture)
- 3. Speed Hump (no crosswalk) on Compton Road at the start of the 30 km/hr school zone to the west of the elementary school.

4. Truck restrictions on Compton Road.

## Conclusion

The cost of the four recommendations are minimal as the City of Port Alberni can utilize city staff to add Speed Humps, road markings and signage. The cost is minimal given the impact on young students and resident concerns as mentioned above. It should be noted that the RCMP does not have a Traffic Enforcement Unit and General Duty members do not have resources to enforce the Motor Vehicle Act. It is understood that there is a complaint from residents on Latham Road about the volume of traffic cutting through their area. This submission should also assist the Lathom Road issues by diverting traffic to River Road. Many jurisdictions within the province have instituted measures such as 30 km/hr in school zones 24 hours a day / 7 days a week. The City of Calgary has these measures but does not address volume of traffic. There are municipalities on Vancouver Island that have instituted measures similar to this request. Finally, all residents along Compton Road have been canvassed and are in support of this request.
