1. Adoption of October 31, 2013 Minutes and 2014 Meeting Schedule

2. DEVELOPMENT APPLICATION - Proposed Official Community Plan and Zoning Bylaw Amendments

- 4961 Melrose Street (PID: 005-632-072) Lot 2, Block 2, District Lot 1, Alberni District, Plan 8025; and
- A portion of Block 58, District Lot 1, Alberni District Plan VIP197B Except Part in Plans 8025, 8425 and 11960. (PID: 008-595-925)

Applicant: M. Van Dyk

- The City Planner summarized his report to the APC dated December 11, 2013.
- The APC discussed the application with respect to the following:
 - The non-conforming aspect of the existing building, to be demolished, was discussed with respect to improvements that would be required when the proposed building is constructed. The current electrical code will be followed and each of the four units in the proposed four-plex will be separately metered.

• The applicant's representatives indicated that contruction was proposed to begin as soon as possible after approvals were obtained from the city.

That the City of Port Alberni Advisory Planning Commission recommends to City Council that the City proceed with a map amendment to the Official Community Plan Schedule A Land Use Map to change the designation of the specified portion of Block 58, District Lot 1, Alberni District Plan VIP197B Except Part in Plans 8025, 8425 and 11960 PID:008-595-925; and, all of Lot 2, Block 2, District Lot 1, Alberni District, Plan 8025, PID:005-632-072 (located at 4961 Melrose Street) from a combination of Park and Open Space Use and Residential Use to Multi-Family Residential Use.
- 2. That the City of Port Alberni Advisory Planning Commission recommends to City Council that the City proceed with a map amendment to the Official Community Plan Schedule B Development Permit Areas Map to include the specified portion of Block 58, District Lot 1, Alberni District Plan VIP197B Except Part in Plans 8025, 8425 and 11960 PID:008-595-925; and, all of Lot 2, Block 2, District Lot 1, Alberni District, Plan 8025, PID:005-632-072 (located at 4961 Melrose Street) in **Development Permit Area No.1 Multiple Family Residential Area**.
- 3. That the City of Port Alberni Advisory Planning Commission recommends to City Council that the City proceed with the following amendment to the Zoning Bylaw Schedule A Zoning District Map to rezone the specified portion of Block 58, District Lot 1, Alberni District Plan VIP197B Except Part in Plans 8025, 8425 and 11960 PID:008-595-925; and, all of Lot 2, Block 2, District Lot 1, Alberni District, Plan 8025, PID:005-632-072 (located at 4961 Melrose Street) from a combination of P2 Parks and Recreation District and R2 One and Two Family Residential District to RM1 Low Density Multiple Family Residential District.
- 4. That the City of Port Alberni Advisory Planning Commission recommends to City Council that as part of the development process the applicant be required to complete the following:
 - a) That a subdivision be completed to consolidate the properties into one legal parcel.
