A. **Zoning Bylaw Text Amendment:**

- 1. Applying to amend the text of Port Alberni Zoning Bylaw 2014, No. 4832 as follows:
- a) By deleting the following text in Section 4 Definitions:
 "Hedge means plant material characterized by dense growth planted in a strip to mark a boundary or enclose or screen an area of land."
- b) By adding the following text to Section 4 Definitions:

 "Hedge means an arrangement of shrubs or low-growing trees that are closely planted in a strip and intended to be maintained at a certain height, used to mark a boundary or enclose or screen an area of land. Does not include vegetation, foliage, or trees naturally occurring on a property."

SUBJECT: Text Amendment to Zoning Bylaw 4382 – to clarify for the definition of

Hedge

<u>Issue</u>

At issue is the consideration of a text amendment to the Zoning Bylaw to modify the definition of 'Hedge' with additional wording to provide greater clarification.

Background

Staff have been asked to clarify the definition of hedge, as the current definition is fairly broad and open to interpretation. In order to more clearly define what a hedge is, staff has recommended "Zoning Text Amendment No. T18 (Hedges), Bylaw No. 4981" to amend the definition in the Zoning Bylaw 4382.

The amending bylaw will be the focus of a public hearing scheduled for April 8, 2019 at City Hall.

Discussion

As currently defined in the Zoning Bylaw 'Hedge' could be misinterpreted to include a row of mature trees. Staff propose that naturally occurring trees on a property, in whatever configuration they occur, should be excluded from the definition of 'Hedge'.

'Hedge' is currently defined as:

"Hedge means plant material characterized by dense growth planted in a strip to mark a boundary or enclose or screen an area of land."

Staff recommend the current definition be replaced by the following:

"Hedge means an arrangement of shrubs or low-growing trees that are closely planted in a strip and intended to be maintained at a certain height, used to mark a boundary or enclose or screen an area of land. Does not include vegetation, foliage or trees naturally occurring on a property." February 14, 2019 Page 2 of 2.

Status of the Application

At the February 21, 2019 meeting of the Advisory Planning Commission the following motions were carried:

- **1.** That the Advisory Planning Commission recommends to City Council that the City proceed with the following text amendment to the Zoning Bylaw:
 - a) "Zoning Text Amendment No. T18 (Hedges), Bylaw No. 4981"

(McRuer / Douglas) CARRIED

At the March 25, 2019 regular meeting, City Council received and accepted the APC recommendations and gave 1st and 2nd reading to "*Zoning Text Amendment No. T18 (Hedges), Bylaw No. 4981*". It is now subject to public hearing, after which Council will have the opportunity to adopt, modify and adopt, or reject the proposed zoning amendment.

Conclusion

In considering the text amendment to the Zoning Bylaw, City Council should consider whether the proposed amendments are appropriate for clarifying the definition of 'Hedge' and if there may be any anticipated negative consequences that may result from the proposed change.

A BYLAW TO AMEND PORT ALBERNI ZONING BYLAW 2014, NO. 4832

The Municipal Council of the City of Port Alberni in Open Meeting Assembled Enacts as follows:

1. Title

This Bylaw may be known and cited for all purposes as "Zoning Text Amendment No. T18 (Hedges), Bylaw No. 4981"
