Dear Guy,

Former ADSS crosswalks on Burde Street and 4-way stop at Estevan Drive RE:

Thank you for your letter of October 27, 2014.

While I understand not wanting to incur the expense of removing the painted lines at the Burde Street crosswalks adjacent to the former ADSS, I ask you to remove the four vertical crosswalk sign posts at these crosswalks. Knowledgeable drivers know these crosswalks are not in effect, yet the signs persist. This results in an "I do not care attitude" related to legitimate crosswalks which increases the potential for incidents.

I ask that you and the Traffic Advisory Committee reconsider the 4-way Stop at Burde and Estevan. You state that vehicles do not stop at the stop signs and there are speeding issues at this intersection. I drive this road on a regular basis and have yet to observe a police patrol at the intersection. What data do you have to indicate the stop sign and speeding infractions?

I accept that there are line issues at the intersection. I suggest that the Burde Street stop signs be removed and signs be erected at the approaches on Burde Street warning of a "Blind Intersection" ahead and that you ask for a frequent police presence to enforce the speeding and failure to stop laws.

Re: Former ADSS crosswalks on Burde Street and 4-way stop at Estevan Drive

Please be advised that the City's Advisory Traffic Committee met on Wednesday, October 15, 2014 and reviewed your request for the removal of the 2 crosswalks on Burde Street at the former highschool as well as the removal of the 4-way stop at the intersection of Estevan Drive and Burde Street.

The Committee discussed the fact that the two painted crosswalks are not a hazard nor an impediment. The lines will fade over time on their own. It was decided to leave them and the signage until the site gets redeveloped as the benefit doesn't exceed the expense to eradicate the lines.

The Committee also discussed the four-way stop at Burde Street and Estevan Drive. There are sight-line and speeding issues at this intersection as well as vehicles not stopping at the stop signs. The Committee decided to defer to safety and keep the four-way stop as it is.

Re: Concern expressed regarding speeding vehicles around parks and school zones

Thank you for your email received October 23, 2014 with regards to your concerns about speeding vehicles around parks and school zones in the city – especially Weaver Park area.

On Wednesday, January 21st the Advisory Traffic Committee met and reviewed your concerns. The Streets Superintendent has recently relocated a speed reader board to Weaver Park. The RCMP and Speedwatch will monitor Weaver Park, 11th Avenue Park (on 10th Avenue and 11th Avenue), and John Paul II Catholic School. Access to power is sometimes an issue when placing speed reader boards. The City will investigate solar powered panels for speed reader boards which will give us more flexibility at more sites in the future.
