PUBLIC INPUT

Neil Anderson

Spoke to outstanding inquiries related to the Kingsway Hotel renovations.

Keith Ambrose

Expressed the importance of ensuring ample opportunity and inclusivity for those members of the public wishing to communicate with Council.

DELEGATIONS

Friends of Burde Street Beaver Ponds

Karen St. Pierre, Chair and Sandy McRuer provided a presentation on the ecological and social value of the Burde Street Beaver Ponds as well as the importance of establishing municipal riparian area protection regulations.

UNFINISHED BUSINESS

Committee of the Whole meeting | Official Community Plan Update [OCP]

Following recommendations from the Committee of the Whole meeting held July 25, 2022, Council approved revisions to Touchstones within the draft OCP Vision and Guiding Principles document and directed staff to proceed with seeking community feedback.

Council further directed staff to implement the OCP Engagement and Communications Strategy as prepared by FRANK planning collaborative.

STAFF REPORTS

RCMP Department

Officer in Charge, Inspector Eric Rochette presented policing activities undertaken during the months of April to June 2022, noting that overall, criminal offences are up by 18% compared to this same timeframe last year.

Old Wastewater Lagoon Desludging

Council awarded a portion of the contract for the Municipal Wastewater Lagoon Desludging (RFP 007-22) project to American Process Group (Canada) Ltd., in the amount of \$450,000 excluding GST. This is the first phase in the decommissioning process of the old lagoon.

Financial Plan Amendments

Council directed that "City of Port Alberni 2022 – 2026 Financial Plan Bylaw No. 5045, 2022" be amended as follows:

- i. Add \$500,000 in 2023 from General Revenue [taxation] for the purpose of increasing the project contingency budget for the Child Care Center Project;
- ii. Amend the overall budget for Project 21024 | Child Care Centre Project from \$2,900,000 to \$4,644,989 to reflect a \$1,244,989 increase in grant funding [total grant funding \$4,144,989];
- Borrow \$210,000 from the Equipment Replacement Reserve Fund [ERRF] in 2022 for the purpose of completing project 21020 - Train Station Seismic Upgrades;
- iv. Transfer \$60,000 in 2022 from Line 29911 -Contingency Funds for the purpose of completing project 21020 - Train Station Seismic Upgrades;
- v. Amend the overall budget for the capital project 21020 Train Station Seismic Upgrades to \$860,000; and
- vi. Assign \$140,000 from Line 29911 –
 Contingency Funds for the purpose of
 funding the City's contribution to
 construction of the 4th Avenue Sleeping
 Pod facility.

BYLAWS

"Zoning Map Amendment No. 51 (5450 Greenard Street – Hopkins), Bylaw No. 5056" was read a third time. The bylaw upon adoption will facilitate the consolidation of existing lots to create 5 new small single-family lots.

"Zoning Map Amendment No. 53 (4925 Leslie Avenue- Needham), Bylaw No. 5059" was read a third time. The bylaw upon adoption will enable the addition of a new small single-family lot.

"Official Community Plan Amendment No. 36, Bylaw No. 5042", "Zoning Text Amendment No. 130, Bylaw No. 5043 and "Zoning Map Amendment No. 47, Bylaw No. 5044" were adopted. The bylaws will enable a high-density multi-family in-fill development at the following properties: 4835 & 4825 Burde Street, 3618 & 3614 5th Avenue creating 40-units of bachelor and 1-bedroom rental housing.

On behalf of the Community Action Team, Council proclaimed August 31, 2022 as 'International Overdose Awareness Day' in the City of Port Alberni.
