DELEGATIONS

Alberni Clayoquot Regional District | Organics Collection

STAFF REPORTS

RCMP Department

Sergeant Wiebe presented policing activities undertaken during the months of April to June, 2021, noting that overall criminal offences are up by 9 per cent compared to this same timeframe last year.

BC Active Transportation Infrastructure Grant | Beaver Creek Path Project

Council authorized staff to apply for funding through the BC Active Transportation Infrastructure Grant Program for the Beaver Creek Path Project, a joint project between the City of Port Alberni and Hupacasath First Nation for the construction of approximately 580m of pathway to improve pedestrian and cyclist safety.

Voting Delegate & Alternates | Municipal Insurance Association of British Columbia

Council appointed Councillor Solda as the City of Port Alberni Voting Delegate to attend the Municipal Insurance Association of British Columbia [MIABC] meetings as per the Reciprocal Agreement between the City of Port Alberni and MIABC.

Council further appointed, Councillor Poon as the first alternate and Councillor Haggard as the second alternate voting delegate.

BC Transit Operating Agreement Amendment

Council authorized the Director of Corporate Services to execute the amended BC Transit Annual Operating Agreement between the City and BC Transit to facilitate a change in fee structure which will provide free ridership for children12 and under effective September 1, 2021.

Audit Committee Terms of Reference

Council reviewed and approved the Audit Committee Terms of Reference as amended with said amendment increasing meeting frequency from twice per year to once every quarter.

Development Permit No. 21-09

Council authorized the issuance of Development Permit No. 21-09, for the proposed construction of 3 single storey storage buildings at 4924 Broughton Street.

Connect the Quays Pathway Update

Council directed that the professional services of John S. Manson P. Eng., and PWL Partnership Landscaping be secured to assist the City with the public engagement phase of the Connect the Quays Pathway Project.

Return to In-Person Meetings of Council

The Director of Corporate Services provided information to Council regarding the anticipated return to in-person meetings of Council starting on Tuesday, September 7, 2021 at 2:00 pm.

BYLAWS

"Solid Waste Collection and Disposal Bylaw 5030, 2021" was read a third time. The objective of this Bylaw is for a solid waste collection program that provides for a three-stream collection service consisting of organics, recycling and solid waste and fees associated with its collection. The bylaw also speaks to service changes to commercial and multi-family collections.

"Sewer Connection and Regulation Bylaw, Amendment No. 14, Bylaw No. 5034" and "Waterworks Bylaw, Amendment No. 12, Rate Changes, Bylaw No. 5035" were finally adopted.

"Official Community Plan Amendment No. 34 (4905 Cherry Creek Road–Evans), Bylaw No. 5031", "Zoning Map Amendment No. 45 (4905 Cherry Creek Road–Evans), Bylaw No. 5032" and "Zoning Text Amendment No. T28 (Definition - Micro-Brewery/Micro-Distillery), Bylaw No.5033" was introduced, given two readings and advanced to a Public Hearing on Monday, August 30, 2021 at 6:00 pm. The amendments would provide the opportunity for commercial interests on site including the proposed operation of a micro-distillery.

CORRESPONDENCE FOR ACTION

Port Alberni Community Action Team [CAT]

Council directed staff to provide a resolution supporting the "Mom's Stop the Harm" petition in response to the overdose crisis to be submitted to the Minister of Health.

Western Vancouver Island Industrial Heritage Society

Council authorized the temporary road closures of Dunbar Street, between 7th & 9th Avenue as requested by the Western Vancouver Island Industrial Heritage Society for the purpose of holding the annual "Antique Trucks & Machinery Show on Friday, September 4, 2021 at 6 pm to Sunday, September 6, 2021 at 5 pm subject to:

- the notification of emergency services and BC Transit
- consultation with all affected businesses/residents
- implementation of a Traffic Plan
- provision of standard liability insurance
- COVID-19 Safety Plan or Communicable
 Disease Plan in accordance with Provincial
 Health orders and guidelines in effect at the
 time of the event
- Capacity/attendees to align with 'BC Restart Plan' guidelines, if applicable

Update: Event organizers have since elected to postpone the event until further notice in response to the recent rise in COVID-19 cases.
