1. **Al Frank**, Hills Road, operator of West Coast Hemp expressed his support for a public input process as part of Council's review of bylaws related to cannabis retail. He commented on his experience with the City in that in following all regulations, other medical marijuana dispensaries were given licenses thereby excluding his business.

1. David Swann, eco-Options Energy Cooperative

David Swan presented the Public Consultation Phase of their proposal to build a \$170 million refinery in Port Alberni (renewable diesel). Mr. Swan indicated the potential of 150-200 jobs on a minimum 5 acre footprint and that they are currently looking at the former Cantimber site and a site on the Bamfield Road.
