### 1. Uptown Merchants Association

Ms. Barb Mellaart, and Mrs. Chris Washington, presented Council with a cheque in the amount of \$520.00 raised by the Uptown Merchants Association. These monies will contribute towards the cost of installing and illuminating white lights in eight (8) trees along 3<sup>rd</sup> Avenue at the conclusion of the holiday season.
