D. Wallace & M. Ramadan | Gaza Ceasefire
Following a presentation from D. Wallace and M.
Ramadan, Council directed that staff write a
letter to Prime Minister Justin Trudeau to request
that the federal government call for an
immediate ceasefire in Gaza.

Council further resolved to condemn all acts of anti-Palestinian racism, islamophobia and anti-semitism in our communities, which have risen since the escalation of violence this past month, and to commit-to working to ensure our communities are just, safe and welcoming for all.

BYLAWS

City of Port Alberni 2023 – 2027 Financial Plan Amendment Bylaw No. 5075-1, 2023 was adopted. The amendment is provided to consolidate all changes made through Council resolution in 2023 within the 2023 – 2027 Five Year Financial Plan.

"Zoning Amendment (3045, 3053, 3063 Kingsway Avenue) Bylaw No. 5096" was introduced and given first reading. The bylaw upon adoption will enable a multi-residential development at 3045, 3053 and 3063 Kingsway Avenue.

Community Investment Program

Council authorized the 2024 Community Investment Program Committee recommendations distributing \$13,449.42 of in-kind and cash funding across 15 local non-profit organizations.

Development Variance Permit No. 117 | 4735 and 4715 Dunbar Street

Council authorized the issuance of Development Variance Permit No. 117 granting a variance to permit an increase to the maximum permitted height of a fence in a front yard from 4 ft (1.25 m) to 6 ft (1.83 m) at 4735 and 4715 Dunbar Street.

Community to Community Grant Application

Council approved the City as an applicant to the Union of BC Municipalities 2023-24 Community to Community Grant Program to support following through on Council's directive to explore having First Nation Representatives at Council meetings.

An application was submitted to the program for funding to cover the costs of 5 meetings in 2024 between the City and the Nations to understand their different approaches to governance, explore options for non-Treaty First Nations participation and input in Council meetings, to review a legal opinion on an option (or options) selected by the three governments and adopt an approach.

Christmas Lights on Johnston Road

The Chief Administrative Officer provided an update that the City of Port Alberni has received approval from the Ministry of Transportation and Infrastructure to install a limited light display on Johnston Road in time for the holiday season.

Somass Lands Update

The Chief Administrative Officer provided an update on the Somass Lands redevelopment
