# PUBLIC INPUT

### Western Vancouver Island Industrial Heritage Society IWVIIHS1

Leslie Walerius of WVIIHS extended an invitation for Council to tour the various sites where Society members restore, maintain and operate vintage vehicles, trains and equipment including the Industrial Heritage Centre and the Alberni Pacific Railway.

Inquired as to the status of the City amending zoning to permit opportunities for property owners to establish 'backyard rentals'.

### DELEGATIONS

#### **United Way BC**

Julie Rushton, Community Impact Manager presented on the amalgamation of six United Ways serving the province to combat similar challenges of inflation, housing, social community services and emergency response, noting a number of local partners the United Way was able to provide funding assistance to in 2022.

#### Official Community Plan Update

Council approved the updated Official Community Plan 'Vision and Touchstones' reflecting community feedback received during the period of August 31 to October 28, 2022. The 'Vision and Touchstones' will shape the content of Phase 4, Policy Development scheduled to take place in the first quarter of 2023.

# STAFF REPORTS

### **RCMP** Department

Officer in Charge, Inspector Eric Rochette presented policing activities undertaken during the months of July to September 2022 and a status update of recent investigations, noting that overall, criminal offences are down by 7% compared to this same timeframe last year.

### BYLAWS

#### **Zoning Bylaw Amendments**

Council received an overview from the Manager of Planning of proposed amendments to the Zoning Bylaw. Topics include secondary suites, accessory dwelling units, day cares, fencing, density calculations, density bonusing and height measurements. Staff will bring forward the draft bylaw to a Committee of the Whole meeting in January 2023.

"City of Port Alberni 2022 – 2026 Financial Plan Amendment Bylaw No. 5045-1, 2022" was adopted. The amendment is provided to consolidate all changes made through Council resolution in 2022 within the 2022 – 2026 Five Year Financial Plan.

was adopted. The bylaw serves to establish a Canada Community-Building Reserve Fund separate from the current Capital Works Reserve providing for simplified administration and management of the reserved funds to assist Council in capital decision making.

### NEW BUSINESS

### Rural Economic Diversification and Infrastructure Program

Council approved the City as an applicant to the Economic Diversification Implementation Grant of the Rural Economic Diversification and Infrastructure Program for remediation and demolition works at the Somas Lands.

Council further authorized staff to allocate \$200,000 in 2023 related to the project for which the grant funds would be sought.

### **Community Investment Program**

Council authorized the 2023 Community Investment Program Committee recommendations distributing \$30,607.00 of in-kind and cash funding across 21 local non-profit organizations.

Development Application | 3008 2<sup>nd</sup> Avenue

Council authorized the issuance of Development Permit No. 22-04 for the Port Alberni Association for Community Living building at 3008 2<sup>nd</sup> Avenue permitting the enclosure of current deck space to construct a meeting room and eight to ten office work stations.

**Development Application | 4467 Wallace Street**Council authorized the issuance of Development
Permit No. 22-06 for a building envelope
remediation of Pioneer Towers at 4467 Wallace
Street which will serve to improve energy
efficiency.

### **Commission and Committee Appointments**

Council released the appointment of two new members, Daniel Holder and Sandy McRuer to the Advisory Planning Commission for a two-year term of January 1, 2023 – December 31, 2024. Council further reappointed Joe McQuaid to the Advisory Planning Commission for a two-year term commencing January 1, 2023 – December 31, 2024.

Council also reappointed Joshua Dahling, Callan Noye, Colin Schult and Craig Summers to the Community Investment Program Committee for a one-year term commencing January 1, 2023 – December 31, 2023.

# Award of RFP 019-22 | Hyperconverged Infrastructure Solution

Council authorized staff to allocate \$154,646.30 to the 2023 Capital Plan Server Replacement Fund in alignment with the five-year replacement cycle and in order to meet the costs of inflation.

Council awarded RFP 019-22 for the purchase of hyperconverged infrastructure equipment [HCI] in the amount of \$324,646.30 to Myra Systems Corporation. HCI equipment will provide server, storage, processing and networking capacities to meet the City's growing data management needs.
