DELEGATIONS

McLean Mill Society

At the request of Council, Bill Collette and Sheena Falconer provided information regarding the Industrial Heritage Society's acquisition of a commercial kitchen for the McLean Mill and recommended that the City provide partial payment to both the commercial kitchen vendor and the Industrial Heritage Society for their down payment on the equipment.

Council endorsed the recommendation from the McLean Mill Society and authorized the payment of \$15,000 to the commercial kitchen vendor and \$10,000 to the Industrial Heritage Society with funding from the Contingency Fund, and further requested that the McLean Mill Society seek to renegotiate the terms of the outstanding balance.

Audit Committee

Public Hearing Report

Hupacasath First Nation Lease

Council authorized the lease with the Hupacasath First Nation for a portion of City owned land located at 4586 Victoria Quay for a five-year term commencing January 1, 2017 at the current rent of \$1.00 for the term (upon completion of statutory notices).

Shared Services

Council received a report from the ACRD CAO, Russell Dyson and CAO, Tim Pley regarding opportunities for shared services.

A joint ACRD Board – City of Port Alberni Council meeting will be held to identify specific services to explore and to develop action plans for 2017.

Tag Days

Council approved the 2017 tag day allocations.

Community Investment Program

Council approved the 2017 recommendations of the Community Investment Program Grant Review Committee and also approved the use of designated 'youth' funds for youth related applications.

Sprout Program

Council received an interim status report on the Sprout Program, which has been established to support small business development in Port Alberni.

Draft Request for Proposal – Gertrude Street

Council provided direction to staff to issue a Request for Proposals for development of the former Tidebrook Motel property at 4356 and 4340 Gertrude Street.

BikeBC Grant Application

Council approved the submission of a grant application to BikeBC for separated shared-use paths on Stamp Avenue between Redford Street and Roger Street.
