PUBLIC INPUT

Maggie Paquet provided input and suggestions in regards to reconciliation and moving forward in a respectful way.

Ellen Frood, Executive Director, ACAWS provided information regarding the 'Coldest Night of the Year' fundraising event taking place on February 25th and encouraged the public to participate.

Gary Spencer-Smith requested changes to secondary suite regulations to attract more investors, create jobs and provide safe, quality, affordable housing.

Hi?hunkennis (Robert Watts) noted that AW Neill spent a large part of his life opposing people like himself as well as other races and suggested it would be a good move on behalf of the City to change the name of the street.

DELEGATIONS

Rosemarie Buchanan

Summarized many of AW Neill's racist viewpoints and provided quotes directly from Hansard. She suggested a street with Neilll's name is harmful and negative and requested Council remove the name from the street.

Cameron Stefiuk

Provided background information on AW Neill highlighting some positive initiatives. He commented we should not forget the past, but learn from it and not repeat the same mistakes going forward.

UNFINISHED BUSINESS

Proposed Renaming of Neill Street

Council received numerous letters regarding the proposed renaming of Neill Street.

Following lengthy debate. Council endorsed a resolution directing staff to bring forward a report at the earliest opportunity proposing options to further the City's efforts and

commitment towards reconciliation in our community.

Council received a report from the CAO providing responses to a letter from Roland Smith regarding the McLean Mill.

Development Permit No. 16-05 (4410 Glenwood Drive)

Council approved Development Permit No. 16-05 to facilitate the construction of a steel frame building at 4410 Glenwood Drive.

Draft Request for Proposals - Westporte

Council received a report from the City Planner and endorsed the RFP for the sale and development of a portion of City owned property off Russell Street adjacent to the Westporte neighbourhood, including a playground.

Oil to Heat Pump Energy Rebate Program Council directed staff to implement Oil to Heat Pump Energy Rebate Program and staff to work with City Green Solutions to move forward with the implementation of an 'Oil to Heat Pump Incentive' leveraging the Provincial 'Oil to Heat Pump Incentive Progam'.

All Mex'd Up Inc., Alberni Harbour Quay Council entered into a lease for Unit #6 at the Alberni Harbour Quay with "All Mex'd Up Inc." (Matt Dunk) for a five year term commencing February 1, 2017.

Application for Funding – FireSmart Planning Grant Program

Council supported an application for funding to the Strategic Wildfire Prevention Initiative FireSmart Planning Grant Program.
