	1. A letter was received by Mayor and Council from Warren Lauder, Councillor for Hupacasath First Nation expressing concern increased traffic on nearby residential streets especially industrial truck traffic.

D **NEW BUSINESS**

- 1. Email received from Cam Pinkerton about Traffic concerns from sd70 admin.
 - a. AES The intersection at Johnston Road and Helen (AES/Tim Horton's) is dangerous. There has been some communication with Randy Fraser regarding painting over the sections no longer in effect with gray to allow for more parking for AES parents/traffic.
 - b. AWN A suggestion to install culverts in the ditches on the north side of Compton Street at AW Neill. This would make it safer for students walking to and from school, parents looking for parking and general vehicular traffic during peak time of the day.
 - c. Gill A concern was voiced regarding the amount of road work around Gill school since September 2013. Sewage upgrades within the same timeframe as paving sections of Beaver Creek Rd and Gertrude St have caused traffic nightmares on many school days this school year.
 - d. 8th Numerous complaints have been received from parents regarding cars speeding on China Creek Rd and not stopping at the crosswalk for students.

	f.	Maquinna - Requesting a crosswalk on the corner of Melrose & 15 th Ave. School uses that crossing for their Fun Run and is also used by many families walking to school. Also a complaint regarding the number of drivers texting while picking up and dropping off. EJD - a parent request for a crosswalk at Argyle & 18 th Avenue Wood - due to the increased traffic along Wood Ave with the new high school, the occasional presence of a traffic police vehicle would be a good reminder to respect the speed limit in the school zone.

Hi Pat,

Here are the traffic concerns that were sent to me:

AES

The intersection at Johnston Rd. and Helen (AES/Tim Horton's) is dangerous. (change to 4-way signalled intersection?)

I've been in communication with Randy Fraser regarding the (now) old yellow painted section of curb along Johnston (no longer used due to bus route changes) across from Tim Horton's as well as the old (no longer in effect) short red and yellow section of curb on Helen Street (close to Johnston)...we need these sections painted over with gray, to allow for more parking for AES parents/traffic.....then they'll be less inclined to park in our crosswalk!

AWN

It would be very helpful if the ditch on the north side of Compton Street along the playing field could have culverts installed since there is no sidewalk on either side of the street. This would make it safer for students walking to and from school, parents looking for parking and general vehicular traffic during peak times of day. Compton is a very busy street throughout the day.

Gill

The amount of road work around Gill school has been a concern since school started. It's one thing to have sewage upgrades directly beside the school but it's another when the city and regional district decides to pave sections of Beaver Creek Road and Gertrude during the same timeframe. Traffic nightmare on many days this school year.

8th

I have had numerous complaints from parents about cars speeding on China Creek and not stopping at the crosswalk for students.

Maquinna:

We were hoping for a crosswalk on the corner of Melrose and 15th. We use this crossing for our run for fun and it is also used for many of our families walking to school. Also..... we had a parent complaint regarding the number of drivers texting while picking up and dropping off.

EJD:

One of our parents has requested a cross walk across Argyle at 18th avenue.

This report was created using a spatial tool that relies on geocodes. ICBC incident counts tend to be lower than Police incident counts on highways due to the fact that when reporting to ICBC, some incident participants do not know their exact location and thus their incidents cannot be geocoded. On the other hand, incidents reported by police usually have accurate location information and can reliably be geocoded.

- 2. A Fatal Victim is defined as a road user who died within 30 days after the date when an injury was sustained in a collision, involving at least one motor vehicle on a 'highway' as defined in the Motor Vehicle Act (largely any public roadway). The Motor Vehicle Act does not apply to forest service roads, industrial roads and private driveways. Fatal victims of off-road snowmobile accidents, homicides, or suicides are excluded from this report.
- 3. In 2008, legislation changed so that police are no longer required to attend all crashes and attendance is at their discretion.
