To Mayor and Council;

My name is Maddie O'Neil-Johns and I am here today to talk about single use plastic straws. Throughout my Independent Directed Study in Social Justice 12 I've been researching about the negative effects of plastic straws. Did you know that Canada uses 57 million single use plastic straws each day! That's 1.57 straws per person!

These straws are much worse then you may think. They are made of a petroleum plastic which can never fully decompose; they are also too light to be recycled meaning they will then be thrown into the trash. Plastic straws turn up in landfills and in our oceans, killing marine life and washing up on our beaches. These straws are in the top 10 for most common litter, as well as waste found on our beaches and oceans. By 2050 plastic is set to outweigh fish in the world's oceans: this is completely unacceptable. Many cities, and even countries, have already outlawed the use of these single use straws to make positive environmental change. Tofino and Vancouver have both recently announced they will be banning single use plastic straws. I believe Port Alberni can do the same.

I know that the scary part is the cost of alternatives. The good news is that it's a lot less then you may think: it's actually not much more than the average plastic straw. Paper straws truly are a cost effective, biodegradable alternative and can run from .03 cents to .087 cents per straw.

McDonalds in the UK has decided to stop the use of plastic straws in over 1300 of their restaurants as of this month! They are replacing them with a biodegradable paper straw instead. They will also be keeping straws behind the counter allowing their customers to ask for straws, therefore discouraging further waste.

I've listed some resources for alternatives to plastic straws along with the price points and sent these resources through the Chamber to businesses in the Valley. I know that running these fantastic businesses take a lot of work and I believe that with information on price points and resources businesses are better able to switch from single use plastic straws to alternatives.

More and more businesses are only providing straws upon request which is an awesome solution as well! Boomerangs has recently decided to do this. Coombs Country Candy has replaced their single use plastic straws with biodegradable paper straws. Many other businesses are also on the verge of change. Port Alberni business owners and managers know that plastic straws are a way of the past.

I hope to have Mayor and Councils support in this issue and to see a new by-law banning the use of single use plastic straws soon.

* Since cannabis and alcohol get compared more and more lately I would like to state a few points:

- 1. The CDC says that from 2006 2010 excessive alcohol use resulted in roughly 88,000 deaths
- 2. Cannabis no deaths
- Alcohol consumption has been consistently linked to a greater chance of getting cancer
- 4. The <u>largest controlled study</u> ever done on marijuana and cancer found that not only is there no link between smoking grass and getting cancer, it may actually result in a reduced chance of being stricken
- Alcohol puts seven times the amount of pressure on healthcare systems if a study released by British Columbia applies everywhere. Their calculations of the <u>difference between</u> healthcare costs for Canadian drinkers vs. weed smokers: \$20.50 per year per toker vs \$165.11 per drinker

This lease is made pursuant to the Land Transfer Form Act

1.0 GRANT:

1.1 The Landlord leases to the tenant the following property, ("the premises"):

Part of the land lying adjacent to Lot 15-17, Block 48, District Lot 1, Alberni Land District Plan 197B, outlined in bold on Schedule A attached to and forming part of this lease agreement.

2.0 TERM:

2.1 The term of this lease is:

Beginning Date: April 1, 2018 End Date: March 31, 2020

3.0 RENT:

3.1 The rent is \$350.00 per year, plus applicable taxes, payable on the first day of each year of the term.

4.0 PERMITTED USES:

4.1 The Tenant may use the premises only for the purpose of access and parking for Tar's Auto Sales.

5.0 TENANT'S COVENANTS:

The Tenant covenants as follows:

- 5.1 To pay rent.
- 5.2 To use the premises only for the purposes set forth in paragraph 4.1.
- 5.3 To pay all property taxes and all water, electrical, gas, security alarm, telephone and other rates and charges imposed for services and utilities in respect of the premises.
- 5.4 To observe and comply with all laws, statutes, regulations, by-laws, rules and orders relating to the premises and the use or occupation thereof.
- 5.5 To indemnify and save harmless the Landlord from and against all claims and losses arising out of or in connection with any activities of the tenant, its servants, agents, contractors, or invitees.
- 5.6 The Tenant shall obtain and maintain for the Term, at its sole expense, comprehensive general liability insurance providing coverage for death, bodily injury, property loss and damage arising out of the Tenant's use and occupation of the Premises, in the amount of not less than \$2,000,000 per occurrence, all inclusive; and

Each insurance policy shall:

- (a) name the Landlord as an additional insured;
- (b) be issued by an insurance company entitled under provincial law to carry on business in British Columbia;
- (c) state that the policy;
 - (i) applies to each insured in the same manner and to the same extent as if a separate policy of insurance had been issued to each insured; and,
 - (ii) cannot be cancelled, lapsed or materially changed without thirty (30) days written notice to the Landlord;
- (d) be maintained for a period ending twelve months after this Lease is terminated;
- (e) not include any deductible amount greater than \$5,000.00 per occurrence; and
- (f) be on other terms acceptable to the Landlord, acting reasonably.
- 5.7 To cause the surface and landscaping of the said lands to be maintained in a good and workmanlike manner.

- 5.10 Not to register this lease in the Land Titles Office.
- 5.11 To repair.
- 5.12 Not to carry on any activity, that may be deemed a nuisance, on the premises.
- 5.13 Not to allow any liens to be filed against the premises. If any improvement as defined in the Builders Lien Act is made to the premises, the Tenant shall post and maintain notices in accordance with that Act.
- 5.14 To lawfully dispose of all waste and debris created by the Tenant on the premises in a manner satisfactory to the Landlord; to keep the premises free of flammable and/or explosive material; to have on the premises at all times fire extinguisher/s as advised are necessary by the Landlord; and to immediately notify the Landlord of any fire damage or other damage or hazards in the vicinity of the premises.

14.1 The Tenant shall pay the Landlord interest at a rate of 2% monthly on any overdue rent or amounts payable under this lease.

15.1 This agreement is subject to any rights created in favour of British Columbia Hydro and Power Authority by virtue of a right of way agreement made between the Lessor herein and British Columbia Power Commission dated the 31st day of December, 1956 and registered in the Victoria Land registry Office under No: 204946-G.

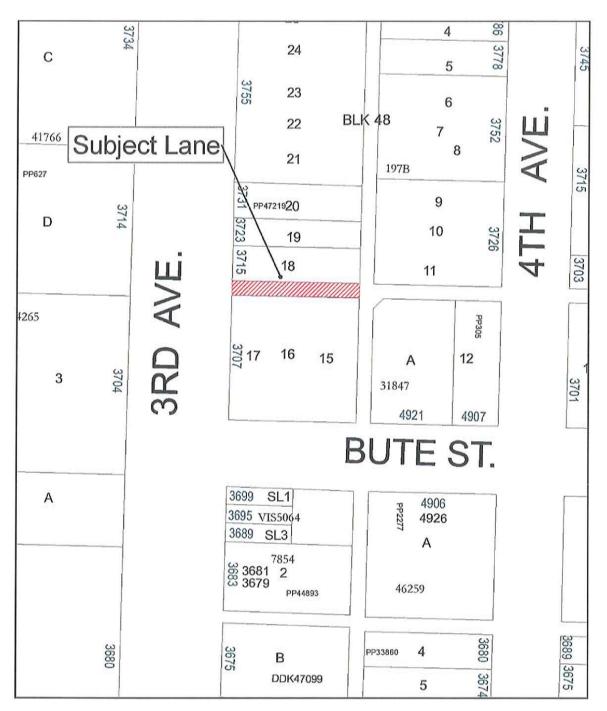

ssue:

Retro-fitting Rescue 8 with the addition of a water tank and pump for response within municipal boundaries and for contract wildfire response outside municipal boundaries for British Columbia Ministry of Forests Wildfire Protection Service (BCWS).

Background:

The City of Port Alberni Fire Department responds to several wildfires within its municipal boundary each year and the department has at times been requested to respond to wildfires outside of the municipality either under contract to BC Wildfire Service (BCWS) or as requested by BCWS under a single event task number.

The Fire Department currently responds to wildfire within the City utilizing one of its main fire engines but also can use an older reserve (1991) fire engine that has been outfitted with wildland firefighting equipment. The reserve engine is due to expire as a reserve engine in 2020.

As we experienced in 2017 with the large wildfire in the Roger Creek area our access with the reserve engine was limited. The size of the engine did not allow us to access the lower portion of Roger Creek and fire was mainly fought from the top which is not ideal but in this case was adequate. A smaller vehicle such as R8 with a water tank and pump could access the lower sections of Roger Creek which could make the difference in suppressing a small fire before it grows and becomes more difficult.

In previous years the Port Alberni Fire Department has also leased a pickup truck and outfitted it with a water tank, pump, and wildland firefighting equipment. This allowed the department to enter into contract agreements with BCWS, to provide an initial response to wildland fires outside the municipal boundary that could potentially threaten the community.

In 2017 the province called for apparatus and staff to assist with the wildfires burning in the central part of the province which many departments responded to and gained considerable revenue from. The City of Port Alberni chose to keep its apparatus and staff in the city to protect the community due to the extreme fire hazard in the valley. However the Wildfire Protection Branch did call upon the City to respond to a fire in the valley but outside of the municipality and the Fire Department did respond under a task number for which it will be paid.

The cost to purchase a new Wildland Brush Truck would range from \$160,000 to \$280,000. The cost to purchase just the wildland deck that could be retro-fitted onto our current rescue truck would range from \$40,000 to \$60,000, but would restrict the current use of the rescue truck.

The fire department's current R8 truck has the capability to be retro-fitted with a water tank, pump and wildland firefighting equipment without compromising its current capacity. Funding in the amount of \$35,000 is being accrued as part of the equipment replacement reserve fund for a Wildland Firefighting Slide in box which is scheduled to be purchased in 2021.

The Port Alberni Fire Department would like to complete the purchase of the Wildland Firefighting Slide in Box in 2018 as part of a retro-fit of R8 to improve its wildland response capability within the City. This would also improve the opportunities for potential response outside municipal boundaries under contract agreement with Ministry of Forests and BCWS as a source of revenue.

The current cost to purchase the Slide in Wildland Firefighting Box for the Retro-Fit of R8 in 2018 is approx. \$25,000.00 and can be completed within 4-6 weeks. This provides a savings of \$10,000.00 from the original \$35,000 projected for 2021, and an immediate increase in capability.

Options:

- 1. Continue with the current response model and wait till 2021 to install the slide in wildland firefighting box as part of the 2021 capital projects budget.
- **2.** Move the purchase of the slide in wildland firefighting box forward to 2018 using funds from the equipment replacement reserve fund.

Recommendation:

That the report from the Fire Chief dated June 11, 2018 be received, and Council for the City of Port Alberni approve advancing the purchase of the Slide in Wildland Firefighting Box from year 2021 in the 2018-2022 Five Year Financial Plan to 2018 with funding from the Equipment Replacement Reserve Fund.

Campground: We have Power!

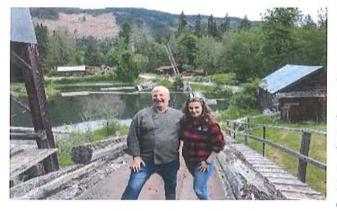

- 3. Correspondence

 - Discussion ensued request that Ms. Freethy be invited to present to the Commission at its March 7 meeting.

- 4. Updates:
 - Discussion of the revised version of City Bylaw No.4687, as distributed to Heritage Commissioners January 22:
 - Voting question of who was eligible to vote determined that all Commissioners had a vote, with one vote per organization – quorum will be half of Commissioners plus one.
 - Question of role advising on request or offering advice proactively? Director Thorpe noted that such language was not required in the Bylaw. Further discussion of the need to ensure that City Council actually would seek the advice of the Heritage Commission.
 - Membership/composition of the Commission suggestion of one representative and one alternate for each organization – number of members revised to 14.
 - Consensus reached that S.6 "Limitation of Number of Terms Served" to be removed – and that S.4.a) – appointment – should have the clause "subject to the approval of the commission" added.
- 5. Potential Use of the Train Station:
 - Bill Collette outlined the proposal of the McLean Mill Society to rent the train station to photographer Darran Chaisson on a month to month basis as a studio and retail space. This will generate revenue prior to the MMS releasing a Request for Proposals for the longterm occupation and use of the Station. The MMS requires rental income as it will be responsible for utility and upkeep costs for the building beginning in 2019. Discussion:
 - Pam Craig noted the potential of such a high-visibility central heritage building to market McLean Mill NHS, sales of tickets, gift shop items, etc.
 - Bill Collette emphasized the need to generate revenue as the RFP process has taken longer than anticipated – noted that the proposed use would encourage "heritage" photo opportunities, and that the MMS would be granted copyright to the photos for promotional and retail purposes.
 - What is the role of the Heritage Commission in this decision? Nancy Blair mentioned that it could help to advise that the uses of the building were compatible with its heritage value.
 - Director Thorpe noted that an RFP should be let prior to even a short-term rental – for the appearance of transparency in the process. Bill Collette suggested a collaborative approach – and it was agreed that Director Thorpe and himself would develop a suitable RFP for the building.

Alicia indicated that an invitation was extended to Mr. Hunter; however, he was unable to join due to a prior commitment. Alicia will extend another invitation to a future meeting at the direction of the Committee.

Alicia walked Committee members through the draft summary of input and noted that pages 19 - 66 are the raw notes, referred to as the Addendum, from the March 27^{th} event. Alicia recommended that only the summary portion of the document (Pages 1 - 18) be distributed via email and that the City post the full 66-page document online, should people wish to see/read their input.



Committee members discussed how they should approach the review process for the summary to best determine next steps for the Committee. Members decided additional time would be required and recommended they meet on May 12, 2018, provided all members can attend. The meeting will be held at the Hupacasath Band Office from 9 am – 1 pm. Alicia will confirm everyone's attendance and send an agenda in the coming days.

It was recommended that copies of the Truth and Reconciliation Calls to Action be available at the meeting to help align next steps in the local Reconciliation process. It was also discussed whether Mr. Hunter should be invited to attend. The Committee elected not to extend an invitation to Mr. Hunter for the review meeting, but instead ask him to a future regular Reconciliation Committee meeting.

Committee members also discussed vocabulary contained in the summary document and debated if the term "First Nation," "Aboriginal," or "Indigenous" should be used. The Committee elected to use "First Nation." Alicia will make adjustments in the summary document to reflect this choice.

4. UBCM Community-to-Community Forum Final Report

Alicia walked Committee members through the Union of BC Municipalities (UBCM) Community-to-Community Forum Final Report which was submitted on April 30, 2018. Alicia will report back on the grant funding outcome at a future meeting.

5. Future Structure of the Reconciliation Committee

Re: Employer Health Tax

Although we appreciate that the recently announced Employer Health Tax is administratively more efficient, it also results in a significant cost increase for many local governments.

The direct impact of this change by 2020 for the District of Kent is that we will be paying twice what we are currently paying in 2018 for Medical Service Plan (MSP) premiums. While many large and midsize businesses will experience significant increases, local governments, unlike businesses, have not benefited from recent business tax reductions.

Local governments have few options to cover cost increases. If unchanged, the new payroll tax will result in increases to property taxes and/or reductions to municipal services resulting from funds being reallocated to cover the Employer Health Tax.

During the 2019 transition year, municipalities will also be burdened with both the MSP premiums and the Employer Health Tax, resulting in increased taxes for many municipalities.

Please consider other options to ease the burden and make an easier transition to the Employer Health Tax cost for local governments.
