PUBLIC INPUT

Frank Kruks described concerns around lack of beds following his recent hospital stay. Council supported his concerns and will write to Island Health regarding the need for more beds.

DELEGATIONS

Island Health

Dr. Paul Hasselback presented local data and stats on a variety of topics including increasing use of alcohol; illicit drugs; marijuana; prescription drug use; limited treatment options and the role for local government.

North Island Students' Union

Council supported the request from Jessica Sandy, Executive Director, North Island Students' Union and Wendy Kerr, Port Alberni Representative, to write to the Minister of Advanced Education seeking to have the provincial government reinstate funding for Adult Basic Education programs.

Heritage Fair

Pam Craig provided information on the upcoming Heritage Fair which will take place on May 6th and 7th.

UNFINISHED BUSINESS

McLean Mill Interim Management Board
Council appointed Bill Collette, Jan Lavertu,
Sheena Falconer and Ken Fyfe to the Interim
McLean Mill Management Board. Susan
Merivirta and Jamie Morton are appointed as
non-voting advisers. Councillor McLeman will be
Council's liaison. The WVIIHS (Western Vancouver
Island Industrial Heritage Society) will be invited
to appoint a liaison. Expressions of interest will be
invited from the public for the three remaining
Board positions at such time as the governance
structure of the Board and Terms of Reference
are confirmed.

Mclean Mill Management Board Terms of Reference

Council received a report from the Director of Community Services outlining the proposed establishment of the McLean Mill Management Operation Board.

Council endorsed a motion to authorize the newly appointed Board to work with the City and the WVIIHS to form a legal entity to draw up terms of reference for the board's operation; liaise with the WVIIHS in regards to operation of the mill and train and to determine interim

operation and funding for the mill/train during the transition period.

Alberni Harbour Quay Lease

Council authorized the Mayor and Clerk to enter into a lease for Unit #6 at the Alberni Harbour Quay with "All Mex'd Up Taco Shop" (Judy Walker) for a five year term.

Lawn Bowling Club Lease

Council also authorized the Mayor and Clerk to enter into a lease with the Lawn Bowling Club for a five year term.
