1. Approval Minutes of the March 3, 2016 meeting

2. Approval of agenda

3. PRESENTATION

4. Agenda preparation and items

Sam Brownlee requested that agenda items be submitted well in advance of our meetings so that it can be circulated to committee members and submitted to the city clerk in a timely manner.

5. Follow up from Chris Alemany on Blue Dot resolution.

The Blue Dot recommendation will be discussed at the next City Council meeting. Some concern has been expressed by a counselor regarding the legal implication of adopting the resolution. Chris Alemany mentioned that the Blue Dot resolution will also be discussed at the Federation of Municipalities meeting in Victoria.

6. Saving the bees/soil remediation

Sam Brownlee suggested that some brownfield lots in the city and city owned land could be seeded with strips of wild flowers to provide food for the bees.

Action: Sam Brownlee and Marcus Lobb will contact Jacob Colyn to discuss what properties could be used to seed wild flowers

Gary Swann suggested that biodynamic preparations and compost would be beneficial in the remediation of brownfield lots.

Action: Chris Alemany will discuss remediation of brownfield lots with Scott Smith, City Planner

Marcus Lobb suggested that more gardens are needed.

Action: Gary Swann will contact Theresa Kingston with the City in regards to the development of a Community Garden policy.

7. City bylaws protecting water courses

Sam Brownlee discussed her concerns with recent tree cutting in riparian zones within the city. We had some discussion regarding the requirement of a permit to cut down trees.
