1. Public Use of Municipal Venues | Recommendation from the November 20th Committee of the Whole

THAT Council direct staff to draft an administrative policy regarding appropriate conduct at municipal venues that includes the following language:

- We understand that this venue includes children, youth, adults and seniors of all races, all religions, all cultures, all abilities, all economic levels, all gender identities and all sexual orientations, and we will conduct ourselves in a manner that is respectful of this diverse community.
- We will comply with all applicable City of Port Alberni bylaws and federal and provincial legislation, including the British Columbia Human Rights Code and Canadian Human Rights Act, which prohibit discriminatory conduct including conduct that would expose persons or groups to hatred or contempt.
- We understand that City staff and their representatives have the authority to ask
 an individual or group to leave a City-owned or City-managed venue when that
 person or group is displaying inappropriate, disruptive, or aggressive behavior that
 threatens the security and safety of staff, guests, residents, themselves and/or
 property. Depending on the seriousness of the circumstances and behaviour, the
 City representative may choose to suspend, ban, or issue a Trespass Notice to the
 corresponding individual or group.

2. Firefighter Resource Planning and Succession | Recommendation from the November 20th Committee of the Whole

THAT Council authorize early budget approval in the 2024-2028 Financial Plan in the amount of \$37,854 [Line 24421] to hire a probationary firefighter for a period of three months to facilitate orientation and training.

3. Canal Beach Pier Resurfacing [Councillor Douglas] - Page 76

- Potential locations including the current location, expansion of the current location and alternate locations;
- ii. The individualized costs of different levels of skate parks and associated features such as pump tracks, jump tracks and any other relevant adventure activity features;
- iii. Identifying potential sources of grant funding available for the construction of such a facility;
- iv. Identifying the level of interest of, and potential contribution from, local and superior intergovernmental partnerships;
- Identifying the level of interest of, and potential contribution from, community
 partners including but not limited to corporate sponsors, service groups and interest
 groups; and
- vi. Effects on the ongoing 5 year operating and capital plans.

5. McLean Mill National Historic Site [Councillor Patola]

WHEREAS, the McLean Mill was declared a National Historic Site in 1989; and WHEREAS, the expected economic benefits of the site have not been successfully attained since the declaration; and

WHEREAS, the Port Alberni City Council has a fiscal and ethical responsibility to ensure that cultural investments are effective in achieving their objectives, whether economic or non-economic;

THEREFORE, BE IT RESOLVED THAT Council direct staff to produce a report for Council, prior to the commencement of the next budget / 5-year financial plan process including:

- i. The yearly income of McLean Mill for the previous 10 years;
- ii. The yearly expenses of McLean Mill for the previous 10 years;
- iii. Itemizing the amount of grants received in any manner utilized for McLean Mill since being designated a national historic site and including the initial Federal Grant;
- iv. The yearly amount of ACRD contributions for the previous 10 years;
- v. The yearly number of visitors to the site separated into classes of visitors, event participants, wedding guests, corporate events or any other such delineation of this nature;
- vi. Options for the disposal of the lands with an assessment of the implications of each option, including potential proceeds of sale and obligations for any required repayments; and
- vii. Any such further information as Administration identifies as relevant to the report.

PURPOSE

For Council to consider three readings to the "City of Port Alberni 2023-2027 Financial Plan Amendment Bylaw No. 5075-1, 2023".

BACKGROUND

Section 165(1) of the *Community Charter* provides authority for the City's Five-Year Financial Plan. Section 165(2) allows Council to amend the Financial Plan, by bylaw, at any time in order to provide for changes that occur during the year. The City's practice, which is common among other municipalities, is to review budget to actual amounts for revenues and expenditures and/or capital project changes throughout the year and to amend the City's Five-Year Financial Plan towards the end of the year so the Plan accurately reflects budget projections for operations and capital.

The following amendments noted below have been approved by Council in the form of a resolution made throughout the 2023 calendar year and are included here for Council's reference.

At Council's May 23, 2023 Regular meeting, Council resolved as follows:

THAT Council amend the "City of Port Alberni 2023-2027 Financial Plan Bylaw No. 5075, 2023" Capital Plan, to increase the funding allocation for "Replace 2018 Freightliner Garbage Truck #401" to \$523,940 coming from the Equipment Replacement Reserve Fund.

CARRIED | Res. No. R23-177

THAT Council amend the "City of Port Alberni 2023-2027 Financial Plan Bylaw No. 5075, 2023" by adding the funding allocation for "2023 Water Meter Renewal" to \$300,000 coming from the Water Fund Reserve.

CARRIED | Res. No. R23-178

At Council's June 12, 2023 Regular meeting, Council resolved as follows:

THAT Council amend the "City of Port Alberni 2023-2027 Financial Plan Bylaw No. 5075, 2023", by allocating \$800,000 towards reconstruction of Burde Street between Anderson Avenue and 16th Avenue with funding from the Canada Community Building Reserve Fund.

CARRIED | Res. No. R23-194

At Council's June 26, 2023 Regular meeting, Council resolved as follows:

- Ongoing funding in the amount of \$136,359 on Line 27510 Museum Services in 2024 with CPI/Collective agreement increases onward.

At Council's November 10, 2023 Regular meeting, Council resolved as follows:

RECOMMENDATION

- 1. THAT "Official Community Plan Amendment (2780 Burde Street) Bylaw No. 5084" be read a third time.
- 2. THAT "Zoning Amendment (2780 Burde Street) Bylaw No. 5085" be read a third time.
- 3. THAT prior to adoption of Bylaws No. 5084 and No. 5085, a covenant be registered on title requiring the property [2780 Burde Street] be connected to municipal sanitary sewer upon future extension of the service.

PURPOSE

The City has received an application to amend the Official Community Plan (OCP) and Zoning Bylaw at 2780 Burde Street. The amending bylaws (No. 5084 and 5085) would change the property's OCP land use designation to Residential (RES), and the zoning to RR2 Semi Rural Residential. This would enable construction of a single-detached dwelling.

BACKGROUND

The historically created lot at 2780 Burde Street (subject property) is significantly smaller than the intended size of properties zoned *FD Future Development*. As a result, the zone's *Site Development Regulations* limit the size of buildings that can be constructed on the property. The applicant is requesting to change the property's land use and zoning to enable more flexibility in constructing a single-detached dwelling on the residentially-sized lot.

Subject Property and Site Context

The subject property is a 1,534 m² vacant lot with frontage onto Burde Street, located approximately 550 metres east of the Uplands residential neighbourhood. A road right of way for Bulwer Avenue used to access a neighbouring property abuts the subject property's western lot line. The subject property is designated *Future Residential (FUR)* in the OCP and is classified *FD Future Development* in *Zoning Bylaw No. 5074, 2023*.

 - THAT prior to adoption of Bylaws No. 5084 and No. 5085, a covenant be registered on title requiring the property [2780 Burde Street] be connected to municipal sanitary sewer upon future extension of the service.
- 2. Council may decline to give third reading.
- 3. Council may direct staff to provide additional information.

ANALYSIS

OCP Policy and Land Use Designation

The proposed *Residential (RES)* land use aligns with surrounding low-density residential neighbourhood and the definition of *Future Residential (FUR)* in Section 4.0 Residential in the OCP. Staff recommend that a "neighborhood plan" not be required as a condition of re-designating the property from *Future Residential (FUR)*. Staff do not consider the *RR2 Semi-Rural Residential* zone to an "urban density" requiring construction of a sewer main as a precondition of development.

Zoning Bylaw No. 5074, 2023

The proposed *RR2 Semi-Rural Residential* zone aligns with existing low-density residential neighbourhood. Proposed zoning permits a higher *Maximum Lot Coverage* (33%) that is more consistent with residential-sized properties such as 2780 Burde Street.

Infrastructure and Servicing

This neighbourhood is not serviced by municipal sanitary sewer meaning the subject property would be serviced by an on-site sanitary system. These are regulated by the Province of BC under the Sewerage System Regulation, and must be designed by an authorized wastewater practitioner. Staff recommend a covenant be placed on property title as a condition of development. The covenant would require the property be connected to municipal sanitary sewer upon future construction of the service extension.

IMPLICATIONS

Supporting this application at 2780 Burde Street would enable construction of a single-detached dwelling. This use is already permitted under the property's existing zoning, however the *RR2 Site Development Regulations* are more flexible. Staff recommend a covenant be placed on land title requiring the property be connected to municipal sanitary sewer if/when service is extended to the Arrowsmith Heights neighbourhood.

COMMUNICATIONS

At the Regular Council Meeting on October 23, 2023, Council gave 1st and 2nd readings to OCP Amendment Bylaw 5084 and Zoning Amendment Bylaw 5085 and advanced the bylaws to a public hearing. A public hearing was held on November 13, 2023.

Prior to the Public Hearing, staff completed all required statutory notifications including mailing letters to all owners and occupants of properties within 100 metres of the subject property as specified in *Development Application Notice Bylaw No. 5076*. Notices were also placed in the newspaper as required by sections 465 and

466 of the *Local Government Act* (LGA). A total of 24 letters were mailed. No correspondence was received and no members of the public attended the public hearing. The Public Hearing minutes are attached to this report for reference.

BYLAWS/PLANS/POLICIES

1. Official Community Plan

The application proposes to change the land use designation from Future Residential (FUR) to Residential (RES). The proposed land use aligns with the Residential designation and OCP policy in Section D: Plan Policies – 4.2 Residential (RES): Permits one and two family residential.

2. Zoning Bylaw No. 5074, 2023:

The application proposes to amend the Zoning Bylaw map to change the classification from *FD Future Development* to *RR2 Semi-Rural Residential*. This aligns with purpose of the *RR2* zone in Zoning Bylaw Section 5.10: The purpose of this zone is to provide for low density development of a semi-rural character.

SUMMARY

Staff support Official Community Plan Amendment Bylaw No. 5084 and Zoning Bylaw Amendment No. 5085 to change the land use designation to *Residential (RES)*, and the zoning classification to *RR2 Semi-Rural Residential* at 2780 Burde Street to enable development of one single-detached dwelling. Staff recommend that prior to final adoption, a covenant be registered on title requiring the property be connected to municipal sanitary sewer upon future extension of the service.





PURPOSE

The City has received an application to amend the Official Community Plan (OCP) and Zoning Bylaw at 3690 Loewen Road and a portion of 2791 Burde Street. The amending bylaws (No. 5092 and 5093) would change the properties' OCP land use designation to *Residential (RES)* and the zoning to *RR2 Semi-Rural Residential* to enable a lot boundary adjustment.

BACKGROUND

The property owner(s) of 3690 Loewen Road wish to purchase a small portion of 2791 Burde Street to consolidate it with the rear of their property. The intent is for the consolidated property to serve as a buffer for their residence located immediately to the north. This process requires a lot boundary adjustment.

Although 3690 Loewen Road would gain land, it still wouldn't meet the required *Minimum Lot Area* of its current *RR1 Rural Residential* zoning. Therefore, the entirety of 3690 Loewen Road and the portion of 2791 Burde Street

to be consolidated both require rezoning to ensure that the resulting lot is in conformance with the Zoning Bylaw. An OCP map amendment is required to align the land use designation with the residential zoning. No development is currently proposed for 3690 Loewen Road post-lot boundary adjustment.

Subject Property and Site Context

The subject properties are located approximately 175 metres north of the Loewen Road and Burde Street intersection. 3690 Loewen Road is a small vacant lot, while 2791 Burde Street is a large lot occupied by one single-detached dwelling. The portion of land at 2791 Burde Street with proposed amendments is approximately 1427 m² and is located in the property's north-west corner. The surrounding area is a mix of large rural lots and historically created smaller lots with single detached homes. Zoning is a mix of future development, rural, semi rural, and residential properties.

ANALYSIS

OCP Policy and Land Use Designation

The proposed *Residential (RES)* land use aligns with surrounding low-density residential neighbourhood and the definition of *Future Residential (FUR)* in Section 4.0 Residential in the OCP. Staff recommend that a "neighborhood plan" not be required as a condition of re-designating the property from *Future Residential (FUR)*. Staff do not consider the *RR2 Semi-Rural Residential* zone to an "urban density" requiring construction of a sewer main as a precondition of development.

Zoning Bylaw No. 5074, 2023

The proposed RR2 Semi-Rural Residential zone aligns with existing low-density residential neighbourhood and the proposed dimensions of 3690 Loewen Road meet the requirements of this zone.

Infrastructure and Servicing

This neighbourhood is not serviced by municipal sanitary sewer meaning the subject property would be serviced by an on-site sanitary system. These are regulated by the Province of BC under the *Sewerage System Regulation*, and must be designed by an authorized wastewater practitioner. Staff recommend that at the time of subdivision, a covenant be placed on title at 3690 Loewen Road as a condition of development. The covenant would require the property be connected to municipal sanitary sewer service upon future construction of the sewer trunk extension.

IMPLICATIONS

Supporting this application at 3690 Loewen Road and 2791 Burde Street would enable a lot boundary adjustment. No new lots would be created.

COMMUNICATIONS

At the Regular Council meeting on October 23, 2023, Council gave 1st and 2nd readings to OCP Amendment Bylaw 5092 and Zoning Amendment Bylaw 5093 and advanced the bylaws to a public hearing. A public hearing was held on November 13, 2023.

Prior to the Public Hearing, staff completed all required statutory notifications including mailing letters to all owners and occupants of properties within 100 metres of the subject property as specified in *Development Application Notice Bylaw No. 5076*. Notices were also placed in the newspaper as required by sections 465 and 466 of the *Local Government Act* (LGA). A total of 25 letters were mailed. No correspondence was received and no members of the public attended the public hearing. The Public Hearing minutes are attached to this report for reference.

BYLAWS/PLANS/POLICIES

1. Official Community

The application proposes to change the land use designation from Future Residential (FUR) to Residential (RES). This land use aligns with the designation and OCP policy in Section D: Plan Policies – 4.2 Residential (RES): Permits one and two family residential.

2. Zoning Bylaw 5074, 2023:

The application proposes to amend the Zoning Bylaw map to change the classification from *RR1 Rural Residential* to *RR2 Semi-Rural Residential*. This aligns with the purpose of the *RR2* zone in Zoning Bylaw section 5.10: *The purpose of this zone is to provide for low density development of a semi-rural character*.

SUMMARY

Staff support Official Community Plan Amendment Bylaw No. 5092 and Zoning Bylaw Amendment No. 5093 to change the land use designation to *Residential (RES)*, and the zoning classification to *RR2 Semi-Rural Residential* at 3690 Loewen Road and a portion of 2791 Burde Street to enable a lot line adjustment.





RE: New legislation to support local government housing initiatives

Over the past week, I have introduced several pieces of legislation to support local governments to get more homes built faster while enabling updated and new tools to effectively fund the costs of infrastructure and amenities to support increased housing supply and growth. Taken together, these changes are critical to getting more of the right kind of housing built in the right places to provide homes for British Columbians.

Last week, I introduced Bill 44, to support communities to deliver the homes people need quickly by allowing small-scale multi-unit housing across BC. These homes, including townhomes, triplexes, and secondary suites, can generally be built in a reasonable timeframe and blend more seamlessly into neighbourhoods. The legislation will apply to many areas of the province, and we anticipate it will allow up to 4 units in single-detached and duplex zones (or 3 depending on the size/type of lot) and up to 6 units permitted in single-detached and duplex zones close to bus stops with frequent service. It will also allow secondary suites or an accessory dwelling unit on single-detached lots throughout BC.

Bill 44 will also speed up the approvals process by moving away from spot zoning to ensure more comprehensive upfront planning and zoning to meet current and future housing needs. The changes include using a robust, standard methodology for calculating long-term housing needs for all Housing Needs Reports to ensure consistency across the

province. Municipalities will also be required to update Official Community Plans (OCPs) and zoning bylaws to ensure their communities have sufficient land designated and zoned to meet long-term housing needs and continue to make these updates on a regular basis. The new legislation will also remove the option for local governments to hold public hearings for rezonings for housing projects consistent with OCPs.

Today, I announced new legislation, Bill 47, to support new housing to get built near high-frequency transit, and yesterday Bill 46, to ensure local governments have tools to collect amenity and infrastructure contributions outside of the re-zoning process.

Bill 47 will require local governments to designate areas near high frequency transit stations as 'TOD Areas.' TOD Areas are near SkyTrain stations and busy bus exchanges and are expected to be identified in 29 municipalities in BC. This is different from the 6-unit requirements in the small-scale multi-unit housing legislation which will focus on properties within 400 metres of bus stops with frequent service. TOD areas will include minimum levels of density, size, and dimension prescribed by regulation. Similar to implementing small-scale multi-unit housing requirements, local governments will have a comprehensive provincial policy manual to assist in making bylaw amendments consistent with the TOD legislation. Off-street parking spaces in TOD areas will be determined by the market; local governments will not be able to require off-street residential parking, other than spaces for other uses like commercial, spaces for disabled persons and loading spaces. These changes will help get more of the right kind of housing built in the right places to provide homes for British Columbians. A subsequent letter will notify the identified municipalities in December.

The new legislation will expand the scope of infrastructure for which Development Cost Charges (DCCs) can be collected to include fire protection facilities, police facilities, and solid waste facilities. It also allows local governments to collect DCCs for provincial highway infrastructure projects where there is a cost-sharing arrangement between the municipality and the Province.

The new Amenity Cost Charges (ACCs) tool will allow local governments to collect monetary and in-kind contributions for amenities (e.g., community centres, recreation centres, libraries) to support liveable communities in areas where new housing is going. This tool will provide certainty and transparency for local governments and developers.

We are aware that local governments require tools and supports to facilitate the delivery of affordable housing in their communities. We are currently exploring policy options and additional tools, including the potential for inclusionary zoning, and I look forward to sharing more about this in the coming months.

I know that the new housing initiatives announced over the past week will take work to implement and require additional resources for your local government to meet the requirements. We have committed to \$51 million in funding for local governments to support planning and capacity to meet these new requirements. The funding will be allocated based on population and the volume of work needed because there are different requirements for municipalities and regional governments. The funding will be distributed in early 2024.

The Province has also provided another \$10 million for a second intake of the Local Government Development Approvals Program (LGDAP), managed by the Union of B.C. Municipalities (UBCM). This funding is in addition to the \$1 billion provided to local governments through the Growing Communities Fund to support the delivery of infrastructure projects needed to support increasing density.

The Ministry of Housing is committed to working together and supporting every community as we move forward with new approaches and new ways to deliver the housing supply our province needs. In the coming weeks, we will be providing policy manuals detailing the site-level specifications for small-scale multi-unit housing and TOD areas. Further guidance will be coming in the new year to support implementation of the development finance tools and pro-active zoning requirements. Ministry of Housing staff will be in touch with your administration in the coming weeks to provide more detail about the changes and about funding and educational support and opportunities.

Good evening Mayors and Regional District Chairs,

I am writing to advise that Bill 31, the <u>Emergency and Disaster Management Act</u> (the Act), received Royal Assent on November 8, 2023, which means the legislation is now in force. Significant components of the Act come into effect immediately, while the remainder will be activated by regulation.

This is the culmination of several years of collaborative work to modernize British Columbia's emergency management legislation to better reflect the world we live in today. It paves the way for a bold, proactive approach to emergency management that emphasizes disaster risk reduction to better prepare and safeguard people and communities against threats, including those related to our changing climate.

I want to extend my appreciation to all those who have participated in engagement on the statute going back to 2019. This includes local governments, various UBCM working groups and committees, emergency management practitioners, individuals, and organizations. Because of your input, the *Emergency and Disaster Management Act* incorporates lessons learned from recent emergencies and reflects modern risks and realities, including climate change. The legislation also adheres to global best practices for disaster risk reduction and incorporates all four phases of emergency management: mitigation, preparedness, response, and recovery.

The Act formally recognizes First Nations' inherent right of self-government in relation to emergency management and is an important step in aligning B.C.'s approach with the *Declaration on the Rights of Indigenous Peoples Act*. The Province is committed to continuing work with First Nations to progress efforts to support alignment under the *Declaration on the Rights of Indigenous Peoples Act*.

Implementation of the full legislation will be phased in over time and we are committed to ensuring local authorities are prepared to meet new requirements, including developing guidance materials and providing other supports. Some of the new aspects of the statute are now available, such as states of local emergency that last 14 days and the ability to declare a recovery period. Additionally, there are now requirements in force related to making reasonable efforts to reach agreement with Indigenous Governing Bodies on geographic areas within which consultation and cooperation will be conducted in the response and recovery phases of emergency management.

Other elements of the legislation will be phased in to provide local authorities with enough time to meet the new requirements. These include responsibilities related to risk

assessments, emergency management plans, and business continuity plans, which will be implemented later through regulations.

WHEN DOES B.C.'s NEW EMERGENCY MANAGEMENT LEGISLATION COME INTO EFFECT?

The new *Emergency and Disaster Management Act* (the Act) has now replaced the *Emergency Program Act* in B.C.

While many powers and duties under the Act are now functional, some components of the Act will become functional once regulations are made to provide further details. Regulations will be phased in over time. The Ministry of Emergency Management and Climate Readiness will be conducting further engagement and consultation to inform how these regulations are developed.

The tables below provide a list of key components that are now functional and key components (grouped by topic) that will become effective after regulations are made. **Note:** this list is not exhaustive and does not include some minor technical components.

Dear Mayors, Councillors & Regional Directors:

I am writing to you today to bring attention to a matter of significant importance currently under debate in the BC Legislature. Bill 45, the *Miscellaneous Statutes Amendment Act (No. 4), 2023*, carries serious implications for municipal governments regarding what they may do when encountering encampments.

We are concerned that Municipal Affairs amendments in Part 1 of Bill 45 (see attached) shift the burden of proof to municipalities regarding the dismantling of encampments, whereas it traditionally falls upon the province to manage and provide supportive housing and shelters. The province's management of shelter space will now directly influence a court's decision on whether an injunction to decamp an encampment can be granted. This legislation will impede local governments' ability to enforce bylaws, making the dismantling of encampments considerably more challenging.

We recognize that in situations where there is insufficient overnight shelter space, the legislation acknowledges the *Charter*-protected right of unhoused individuals to take temporary overnight shelter in parks or public spaces, as established in the case of Victoria (City) v. Adams, 2009 BCCA 563.

However, recent court decisions have granted injunctions for the decampment of dangerous encampments without the precondition of available shelter space or housing. Examples include Nanaimo (City) v Courtoreille, 2018 BCSC 1629, Saanich (District) v Brett, 2018 BCSC 1648, and Maple Ridge (City) v Scott, 2019 BCSC 157.

It is important to emphasize that the overarching responsibility and jurisdiction to create and manage shelters lies with the Province of B.C. and not municipalities.

PART 1 - MUNICIPAL AFFAIRS AMENDMENTS

Community Charter

Explanatory Note

1 The Community Charter, S.B.C. 2003, c. 26, is amended by adding the following section to Division 4 of Part 8:

Availability of shelter

- 274.1 For the purposes of enforcing, under section 274, a bylaw against a person who is sheltering at an encampment while homeless, alternative shelter is reasonably available to the person and meets the basic needs of the person for shelter if
 - (a) the person may stay overnight at the shelter,
 - (b) the person has access to a bathroom and shower at or near the shelter,
 - (c) the person is offered without charge one meal a day at or near the shelter, and
 - (d) the shelter is staffed when persons are sheltering at the shelter.

Vancouver Charter

Explanatory Note

2 The Vancouver Charter, S.B.C. 1953, c. 55, is amended by adding the following section:

Availability of shelter

- **334.1** For the purposes of enforcing, under section 334, a by-law against a person who is sheltering at an encampment while homeless, alternative shelter is reasonably available to the person and meets the basic needs of the person for shelter if
 - (a) the person may stay overnight at the shelter,
 - (b) the person has access to a bathroom and shower at or near the shelter,
 - (c) the person is offered without charge one meal a day at or near the shelter, and
 - (d) the shelter is staffed when persons are sheltering at the shelter.

Dear Respected Colleagues/Community Partners,

I wish to take this opportunity to update you on RCMP Commissioner Mike Duheme's visit to British Columbia last week.

However, I first want to thank you for your support following the on-duty homicide of Constable Frederick "Rick" O'Brien on September 22, 2023 in Coquitlam, B.C. I know that many municipal representatives attended the regimental funeral on October 4, 2023 at the Langley Events Centre and your presence there was sincerely appreciated by the family of Constable O'Brien and his RCMP colleagues.

While Commissioner Duheme touched on several topics in media interviews during his visit, he asked that I pass along his assurances that specific action is being taken in relation to recruiting and vacancies here in British Columbia. These actions to date include:

- 1. Modified recruiting practices that see applicants returning to their home province if they choose to do so-98 percent-do!;
- 2. Streamlined recruiting practices to reduce delays and increase the speed of processing applicants;
- 3. Ongoing recruiting and information sessions at detachments, career fairs and community events nearly 175 across the province so far this year;
- 4. Divisional processing and selection of the Experienced Police Officers (EPO) program to streamline applications for quick entry into duty;
- E Division is one of three divisions embarking on a pilot to develop a de-centralized model for recruiting. E Division would continue to be responsible for proactive recruiting, and would add administrative processes for file management all the way up to troop loading at Depot.

These actions are leading to significant momentum in recruiting and hiring trends throughout BC and nationally as follows:

- 1. Applicants: There are 6,072 applicants in process across the country. This represents, 1,997 applicants that are within the divisional proactive unit stage, and 4,075 active applicants at assessment phase and beyond;
- 2. BC Applicants: Most recent number is 2,109 applicants. This number is fluid;
- 3. Experienced Police Officer (EPO) program: 108 EPOs hired in BC since last year. Specifically, 43 were hired in the 2022/2023 fiscal year. This year, so far, 65 EPOs have been hired;
- 4. EPO increase: EPO hiring has increased 51 percent this year over last fiscal year. These officers are serving all over British Columbia;
- 5. Diversity: 39 percent of all recent BC applicants, self-identify as members of a racialized community and Indigenous persons;

- 6. Cadets and Troop Load: We have increased troop size from 24 to 32. Troops 17 forward (August 2023) are now being loaded at 32.
- 7. BC RCMP Cadets: E Division receives approximately 1/3 of cadets.

Of all our initiatives, the most positive feedback we are receiving is the ability of new cadets to return to their home province of British Columbia. Given the high number of BC applicants, we have also initiated bi-monthly "Pathways" presentations at Depot to showcase BC RCMP posting opportunities in Northern BC.

The second bit of feedback cited by our Experienced Police Officers and cadets as a factor for joining the RCMP, are the vast number of career options available to serve our communities. The RCMP has a lot to offer – from career diversity, world class training, competitive salaries and comprehensive benefits.

In a competitive labour market, this is of significant appeal to our target applicant group and, with wage equivalency to other police agencies, is a driving factor in making the RCMP an employer of choice.

We are committed to continuing to support these processes and adding others to ensure we continue the momentum in serving our communities and responding quickly to those needs.

Emergency & Disaster Management Act Regulations Zoom Session by the Ministry of Emergency Management and Climate Readiness (9am to 4pm)

This session was on the development of the post emergency financial assistance and local authorities' regulations that will support the new Emergency and Disaster Management Act. Looking forward to seeing the completed report.

November 16th

Alberni Valley Regional Airport Committee Meeting

Airport was awarded the 2023 William Templeton Award (the award is annually awarded for outstanding initiative and achievement in the successful development of a community airport or floatplane landing facility by an individual association, municipal government, or company.

Our regional airports have been the only ones recognized three times -1992 (AV); 2017 (Tofino); and present. Last year we were the runner-ups. We also looked and discussed leases and how other communities charge. I was asked when the trees will be cut so we can move forward finally (it's been five years in the plan) where planes land on instrument and no visual. Summer to late September 2024 completion. Inspectors are looking at the frequency change with Transport Canada. A new fuel dispenser in February. I was asked if we could get a report from the pilots that used our airport during the wildfire. 




Overhead of existing pilings





I have completed inspections on the wood pilings at Waterton Park as you requested. Except as noted below all pilings are in good condition based on the drilling inspections.

There are a few pilings with rot pockets at the top of the pilings, and a quite a few of the short timbers above them that are completely rotted thru-out, other pilings have split and/ or been pushed away from their positions by wayward boom logs that have made their way into the pilings. With the wave and wake actions in that area they have moved the pilings out of their original positions.

The pilings I tested were the main pilings holding up the support beams, I did not inspect the random pilings on the west side as they did not appear to be part of the actual structure, also the set of pilings in front of the large concrete pads were also not inspected as they appeared to be damaged to be of any use in your plans.

All the pilings and beams that I found with issues have been flagged for identification if work will be done on the pier. I have sent pictures of the affected sections.
