PUBLIC INPUT

Major Rai attended to provide information regarding the provincial application process for licensing to operate a cannabis retail store.

DELEGATIONS

Alberni Valley Social Planning Council
Ron Jorgenson representing the AVSPC
attended to request Council move forward
with the creation of a Social Planning
Commission. Council recognizes the need
for a formal process and directed staff to
provide a report and recommendations
once the new Planner is in place in January.

STAFF REPORTS

Cannabis Retail

Council endorsed the recommendations in the November 14, 2018 report from the Manager of Bylaw Services and the Consulting City Planner and directed staff to bring forward amendments to the City's Zoning and Business Licensing Bylaws allowing for transition from medical marijuana dispensaries to cannabis retail businesses.

- Cannabis retail added as a permitted use in all four (4) commercial zones - C2, C3, C4, C7
- No setbacks from similar businesses
- 300m setback from schools

Remedial Action Requirement

Council authorized the request from the Bylaw Services Manager to impose a remedial action requirement on the property at 2622 2nd Avenue:

To demolish the damaged building

- To remove all debris from the demolition to an appropriate disposal site; and
- Level the site

The property is to be brought into compliance by December 27, 2018

Cruise Ship Attraction

Council received a report from the Economic Development Manager providing an update regarding cruise ship attraction efforts.

BYLAWS

The following Bylaws were finally adopted:

- "Bylaw Offence Notice Enforcement Amendment Bylaw No. 4929-3
- "City of Port Alberni Building Standards Bylaw No. 4975, 2018"

"Zoning Bylaw Map Amendment No.30 (4000 Burde Street - Anderson Hill), Bylaw No. 4977" and "Zoning Bylaw Map Amendment No. 31 (3503 11th Avenue -Sattar), Bylaw No. 4978" were given first and second reading and advanced to a Public Hearing on January 14, 2018 at 6:30 pm in the City Hall Council Chambers.

"Five Year Financial Plan 2018-2022, Amendment No.1, Bylaw No. 4960-1" was introduced and read three times.

CORRESPONDENCE

Walk for Peace

Council granted the Roman Catholic Parish permission to use City streets for their annual "Walk for Peace Day" on January 1, 2019, subject to no disruptions to traffic and the group assuming full responsibility for the event.

Alberni-Clayoquot Regional District - Community Child Care Planning

Council will provide a letter in support of the Alberni-Clayoquot Regional District's application to the Community Child Care Planning Program for funding to undertake child care planning activities and develop a 'community child care space creation action plan' for the region's communities.

Roland Smith - McLean Mill

Council referred correspondence from Roland Smith regarding contaminants located on McLean Mill property to an upcoming meeting when a full report regarding the status of the Mill is provided by the CAO.

Blake Johnson - Port Alberni Welcome Signage

Council received a letter from Blake Johnson requesting welcome signs be amended to reflect "Port Alberni" instead of "Alberni Valley" and a background report from the Economic Development Manager advising a broader discussion regarding signage is required.

Food Security and Climate Disruption Committee

Council received a letter from the Food Security and Climate Disruption Committee and approved their request to extend the terms of their current members to allow for transition and amend the Terms of Reference to appoint either an additional member at large or an appointee from SD70.
