2. Approval of agenda

Guy Langlois asked to add business licences requirement and insurance for market gardeners.

- 3. Discussion with Janette Cormier regarding the Community Garden and possible participation in alternate sites.
 - 6 people on the waiting list for plots
 - Presently have 14 allotments @ \$25/yr and 5 communal beds
 - VIHA and Friendship Centre participating
 - Water supplied by city. Conserving water by hand watering
 - Fencing was provided and built by the See Group and Beaver Creek Home Center
 - Would like to have a seating area and a tool storage shed built
 - Would like to expand the garden area to accommodate new gardeners
 - Plan to plant fruit and nut trees. Applying for grants
 - Soil has to be brought in for the beds
 - Interest in starting a compost education program. Concern with attracting animals
 - Sam Brownlee and Rosalind Chapman investigated alternative community garden sites

Action: Guy Langlois will contact Jim Lawson and NIC to ask if their students would be interested in constructing a gazebo and a tool shed for the garden

Action: Gary Swann expressed interest in assisting with the compost education program by doing a demonstration on site

- 4. Discussion with Jen Fisher-Bradley regarding Model Forest Policy program
 - \$10,000 requirement to participate in the program
 - Consist of participating in webinars
 - Goal is to establish a climate action plan
 - This is an American initiative. No present action in Canada
 - Gary Swann indicated that there was a model forest in Ucluelet and there was a national program. There is also an eco-forest program in Cedar
