PUBLIC INPUT

Commented on traffic and pedestrian safety concerns. Council directed that staff forward the information to the Traffic Advisory Committee.

Port Alberni Cubs Oldtimers Baseball Club

Rob Ivezich presented an opportunity for the City to host the 2023 Canadian National Oldtimers Baseball Federation Championship.

STAFF REPORTS

Canadian National Oldtimers Baseball Federation Championship

Council directed staff to proceed with next steps as required to host the Canadian National Oldtimers Baseball Federation Championship in August 2023.

Wastewater Treatment Facility Upgrade | Municipal Security Issuing Resolution

Council provided a Municipal Security Issuing Resolution to enable borrowing from the Municipal Finance Authority of British Columbia, prompting the request that the Alberni-Clayoquot Regional District consent this borrowing over a 30-year term and include the borrowing in a Security Issuing Bylaw.

The \$8,500,000 in funding was authorized by Council in June 2022 through the "City of Port Alberni Wastewater Treatment Facility Upgrade Loan Authorization Bylaw No. 5038, 2021".

Somass Lands

Council authorized Bowerman Construction to continue providing project management services to the City in relation to the Somass Lands and in particular salvaging efforts and identification of components for future sale, until December 31, 2022 pursuant to a Notice of Intent.

BYLAWS

"City of Port Alberni Permissive Tax Exemption Bylaw No. 5068, 2022" and "City of Port Alberni Permissive Tax Exemption Bylaw No. 5069, 2022" were adopted. The bylaws will enable the applicants [Alberni Drug and Alcohol Society, Kuu-us Crisis Line Society and Island Corridor Foundation] to receive permissive tax exemptions as per the Community Charter which provides Council the authority for both permissive and statutory tax exemptions for properties owned by a charitable, philanthropic or other not-for-profit corporation.

"Zoning Map Amendment No. 54 (3151 3rd Avenue – Dog Mountain Brewing), Bylaw No. 5064" was read a third time. The bylaw upon adoption enables the applicant, Dog Mountain Brewing, to rezone 3151 3rd Avenue from C5 Transitional Office to C7 Core Business expanding their non-brewing business operations (kitchen, lounge, office, picnic area) onto the neighbouring property.

"Zoning Map Amendment No. 55 (5801 and 5837 Compton Road – Cicon), Bylaw No. 5065" was introduced and given two readings. Given the amendment aligns with the City's Official Community Plan, Council proceeded to waive the public hearing and directed that staff provide notice to properties within 75 metres, inviting feedback prior to Council's consideration of further readings at the November 28th Regular meeting.

The proposed bylaw upon adoption would enable subdivision of the properties resulting in the creation of two additional lots.

"Zoning Map Amendment No. 56 (2244 Mallory Drive – Saywell Developments), Bylaw No. 5066" was introduced and given two readings. Given the amendment aligns with the City's Official Community Plan, Council proceeded to waive the public hearing and directed that staff provide notice to properties within 75 metres, inviting feedback prior to Council's consideration of further readings at the November 28th Regular meeting.

The proposed bylaw upon adoption would enable the construction of a duplex.

"Zoning Map Amendment No. 57 (2272 Mallory Drive – Saywell Developments), Bylaw No. 5067" was introduced and given two readings. Given the amendment aligns with the City's Official Community Plan, Council proceeded to waive the public hearing and directed that staff provide notice to properties within 75 metres, inviting feedback prior to Council's consideration of further readings at the November 28th Regular meeting.

The proposed bylaw upon adoption would enable the construction of a duplex.

"Official Community Plan Amendment No. 38
(4210 Cedarwood Street – Citaapi Mahtii Housing Society), Bylaw No. 5051" and "Zoning Map Amendment No. 49 (4210 Cedarwood Street – Citaapi Mahtii Housing Society), Bylaw No. 5052" were adopted. The bylaws will enable a high-density multi-family residential development at 4210 Cedarwood Street.

PROCLAMATIONS

On behalf of the Alberni Valley Restorative Justice Society, Council proclaimed the week of November 20 – 26, 2022 as 'Restorative Justice Week' in the City of Port Alberni.

CORRESPONDENCE

Alberni-Clayoquot Regional District

Council authorized the Alberni-Clayoquot Regional District to apply to the Union of BC Municipalities 2023 Community Resiliency Investment Program to receive and manage grant funding on behalf of the City of Port Alberni as it relates to increasing the community's resiliency by undertaking community base FireSmart planning and activities that reduce the community's risk of wildfire.

Grass Roots Homelessness Coalition

Council authorized the Mayor and the Corporate Officer to enter into and execute a Licence to Occupy Agreement between the City of Port Alberni and the Grass Roots Homelessness Coalition effective October 15, 2022 and terminating April 30, 2023 for the purpose of providing temporary warming places on City owned lands.
