PUBLIC INPUT

A young resident commented on the correspondence from Aaron Brevick (part of this agenda) and put forward for consideration that medical marijuana dispensary windows should be blacked out to ensure more privacy.

DELEGATIONS

Alberni Valley Chamber of Commerce

Bill Collette provided a brief update regarding the Tri-Conic Challenge and presented Council with T-shirts promoting the event. He also introduced the newly hired project manager for the Tourism Training project.

Rotary Arts District (RAD) Corps

Brent Ronning and Lily Diotte attended to request Council's support for a Creative Crosswalk project, particularly:

- Support for the Community Investment Program grant application for the Artists fee.
- Commitment to installation and on-going maintenance of the crosswalks.
- Participation on the Creative Crosswalks ad hoc committee.

Council will consider the issue further during the upcoming budget process.

Heather Shobe, ACRD Agriculture Development Committee

Council will provide a letter of support for the ACRD application to the Grow-Local Program through the Investment Agriculture Foundation of BC for funding to support communities in 'growing local" by providing educational resources and hands on practical advice.

STAFF REPORTS

Upcoming Budget 2017 - 2021

The CAO provided information pertinent to Council's direction on the upcoming budget with emphasis on long-term planning (Presentation available on the City's website).

The Deputy City Clerk outlined the development process of the 2017 – 2021 Five Year Financial Plan which will take a different format this year and will include potential for an e-town hall meeting. A budget survey is being launched October 25, 2016 inviting public feedback and comment. Council direction is expected at the next meeting on November 14th.

Rural Dividend Fund

Council authorized the submission of an application from the Economic Development Manager to the BC Rural Dividend Program, in partnership with FP Innovations, for the Port Alberni Maximized Value Wood-Biomass Eco-Industrial Cluster.

Port Alberni RCMP Detachment Occupancy Agreement

Council authorized the Mayor and Clerk to enter into an occupancy agreement with the Royal Canadian Mounted Police for the Detachment Building at 4444 Morton Street for a five year period effective January 1st, 2017 ending December 31st, 2021.

BYLAWS

"City of Port Alberni Cemetery Management, Amendment No. 1, Bylaw No. 4922" was introduced and read three times.

CORRESPONDENCE

Aaron Brevick

Council received a request to amend Zoning Text Amendment No. T7 (Marijuana Dispensary Regulations), Bylaw No. 4893 to remove adult based learning places (colleges and universities) from the interpretation and add preschools, daycares and childcare facilities which are not currently addressed.

Council received a request to provide the total costs of the Gertrude Street Bridge Project. A response will be provided.
