STAFF REPORTS

WWTP Upgrades - Effluent Pump Station Platforms Contract Award

Council awarded the contract for the Wastewater Treatment Plant Upgrades for the supply, manufacturing and installation of two Effluent Pump Station Platforms to Tritech Group Ltd. at a cost of \$3,229,180.75 plus GST.

RFT 028-19 Gertrude Street Bridge Deck Joint Replacement Contract Award

Council awarded the contract for the Gertrude Street (Roger Creek) Bridge Deck Joint Replacement to Mainroad Mid-Island Contracting for \$83,870.00 plus GST.

Works are scheduled to begin the latter part of December/early January.

Climate Leaders Institute Workshop

Council authorized Councillor Poon to attend the Climate Leaders Institute two-day workshop on November 7th & 8th in Richmond, BC.

2020 - 2024 Financial Planning (Budget) – Proposed Schedule/Timelines

Council approved its 2020-2024 Financial Planning Schedule generally as outlined in Staff's report dated October 21, 2019. While Council will entertain departmental presentations in early December, Council intends to introduce the City's 2020-2024 Five-Year Financial Plan [by giving it first reading] at its Regular meeting in January 2020.

Harbour Quay Lease Unit #13

Council authorized the Mayor and Clerk to enter into a lease for Unit #13 at the Alberni Harbour Quay with Gwen and Norman Lowe for the purpose of operating retail sales of crafts and wooden toys for a term commencing December 1, 2019 to November 30, 2021, at the current monthly rent of \$299.22 per month plus applicable taxes.

Current Bylaw Department Initiatives

Council received a report from the City Clerk providing an update regarding current Bylaw Department initiatives and the City's continued efforts in promoting the Bear Smart program and residents responsibilities in regards to garbage; educating the public as it relates to utility/boat trailers and RVs being stored on City streets or boulevards (in contravention to the City's traffic Regulation Bylaw). Bylaw enforcement is currently issuing 'warning tickets' to owners of these trailers/RVs who are contravening the bylaw.

The City's graffiti removal program remains active and available to property owners who have been affected by vandalism. Residents are reminded to report graffiti to the Bylaw department in order that it may be addressed in a timely manner.

"Five Year Financial Plan 2019 - 2023 Amendment No. 1, Bylaw No. 4984-1" was finally adopted.

"Business Licence Regulation Bylaw, City of Port Alberni, Bylaw No. 4951-2" was finally adopted.

Public Hearing

The report of the Public Hearing held October 15, 2019 regarding Bylaw No.'s 4995 and 4996 was received.

"Official Community Plan Amendment No. 28 (5536 and 5546 Swallow Drive – Power), Bylaw No. 4995" and "Zoning Bylaw Amendment No. 36 (5536 and 5546 Swallow – Power), Bylaw No. 4996".

"Lane Closure Adjacent to 3508/3514 – 4th Avenue and Removal of Dedication, Bylaw No. 4999" was given three readings and will be advertised to the public prior to consideration of adoption on November 12, 2019.
