1. Approval of Minutes from June 9, 2015

Gary Swann moved to approve, Chris Alemany Seconded

2. Approval of Agenda

- Moved item a) to the end of the meeting to accommodate our guest speakers.
- Added letter from Jen Fisher Bradley for discussion at the end of the meeting.

Gary Swann moved to approve, Sandra Gentleman Seconded

3. Discussion with Russell Dyson, CEO ACRD - Status of proposal submitted to the ACRD for rain water harvesting rebate program.

Russell Dyson discussed how the rain water harvesting rebate program could be funded by the ACRD. It was suggested that our best option would be to apply for funding support from the Grants in Aid program. To be eligible an independent organization would have to apply and administer the programs. There was some discussion regarding the Farmers Institute assuming this role. The ACRD would be receiving applications in January and February.

4. Presentation by Heather Shobe and Anna Lewis Agricultural Support Workers for the Alberni-Clayoquot Regional District - Water harvesting grant application for funding from the Real Estate Foundation.

Motion:

To support for the Agricultural Support Workers application for funding request from the Real Estate Foundation of BC to develop policy and procedures for the agricultural use of water, both urban and traditional, within the Alberni Clayoquot Regional District.

Gary Swann moved to approve, Sandra Gentleman Seconded.

Action:

Guy Langlois will draft a letter of support and circulate it to the committee members for approval.

5. Presentation by Heather Shobe and Anna Lewis, Agricultural Support Workers for the Alberni-Clayoquot Regional District, regarding making recommendation to Port Alberni City Council:

- That any requirement for a business license be waived for market gardeners within the City of Port Alberni, and that the public be notified of this incentive;

Guy Langlois pointed out that he could not find any examples of a municipality waiving business license fees for market gardeners. The city of Vancouver is presently looking at this as they have been allowing market gardeners to operate and sell produce without a business license for several years. Market gardeners have expressed that they would prefer to be issued business licenses as then they would be able to apply for liability insurance.

Action:

Guy Langlois will contact Ken Watson and get his opinion on whether or not a business license would be required or if a special business license, at a reduce fee, would be considered for market garden operations.

- That the city investigate the cost of and implement a reduced water rate for market gardeners, as a support measure for increased urban agriculture;

Guy Langlois stated that he would support reduced water rates for market gardening operations if there was a requirement for market gardeners to implement water conservation measures like, rain water harvesting, drip irrigation and water timers.

- That the city investigate the possibility of producing a map/weblinks with a list of urban farmers and market stands;

This topic was brought up at a previous FSCCC meeting by Jen Fisher Bradley. It was decided that the AVTTS has developed an on-line food directory and map. It was recommended that the city support this initiative.

- Extending liability insurance to those small farm stands on the route provided they work within regulations required by the insurer.

Guy Langlois stated that liability insurance would be the responsibility of the land/business owner.

Action:

Guy Langlois will contact Ken Watson and get his opinion on whether or not liability insurance for market garden operations could be covered under the City's insurance policy.

6. Presentation by Edna Cox - AVTTS Food Group - Regarding plans on Food Security in Alberni Valley.

- Edna Cox provided an exhaustive history and review of the accomplishments of the Alberni Valley Transition Town Society (AVTTS) and the work that the Food Group committee has done to improve food security in the Alberni Valley.

Future plans are to:

- Form a Food Security Round Table to develop a Food Action Plan for the Alberni Valley;
- Draft a Strategic Plan to develop a Food Hub for the Alberni Valley;
- Seek funding to hire one staff person to administer the food hub and to find affordable office space.

Russell Dyson expressed his support and suggested that the AVTTS make a formal request to the ACRD board for support.

Gary Swan also indicated that the AVTTS may also make a funding request from the AV Community Forest Corporation.

7. Email correspondence from Jen Fisher Bradley

It was decided that we request that Jen Fisher Bradley make a formal presentation at our next FSCCC meeting.

8. Sam Brownlee asked if the letter that was sent from the City of Port Alberni to North Island College (NIC), requesting that the college consider developing agricultural programs in the Alberni Valley.

- Chris Alemany stated that city council had passed a motion to send a letter to NIC but did not hear if the city had received a reply.

Action:

Guy Langlois will contact NIC and ask if the request by the city was considered.

9. Correspondence: Letter from AV Community Forest Corporation in regards to sequestering carbon.

Dear Guy Langois:

Thank you for your letter dated July 10, 2015. The Alberni Valley Community Forest Corporation (AVCFC) is active in seeking public input to help us manage the Community Forest.

The Alberni Valley Community Forest Corporation (AVCFC) has provided the public with a questionnaire at all of our public presentations. One of the key values the public has stated in the response to these questionnaires is to protect Old Growth Forests in the Community Forest and especially those in the Sproat Forest Development Unit. The protection of second growth to allow it to sequester more carbon has not been a key item of concern for the general public but it is defiantly an issue that should be considered.

The Community Forest is trying to achieve a balance of harvesting some Old Growth Forest in the Taylor Forest Development Unit and second growth in the Sproat Forest Development Unit. The community forest completed an inventory assessment and based on the results we have reduced our yearly cut. The main reason for the reduction was that the second growth is too young to harvest and it needs more time to reach a harvestable size.

Since the AVCFC operates on crown land, the Ministry of Forests Lands and Natural Resource Operations (MFLNRO) guides us on harvest levels. If we do not meet the harvest levels set by MFLNRO and do not have good reasoning for this the government can give our allocation of timber to another party.

The AVCFC has been lobbying MFLNRO to give us more land with larger second growth so we can leave our current smaller second growth so it can grow longer and sequester more carbon.

To reduce carbon output from the community forest we are managing our waste wood so it will be utilized in the new active carbon plant that will be located along the harbour. Where possible our waste wood will no longer be piled and burnt. It will now be ground up and trucked to the water front to be turned into activated carbon for filtering systems.
