Introductory Remarks from Mayor Minions

Mayor Minions offered condolences on behalf of Council and the City to the family of former City Manager, Mayor and Freeman of the City, Jim Sawyer, who passed away on September 4, 2022, recognizing his lifetime of achievements and countless contributions to the community.

DELEGATIONS

Mosaic Forest Management

Colin Koszman, Land Use Forester, and Molly Hudson, Director, Sustainability provided Council with an update on local topics of interest including public access and the BigCoast Forest Climate Initiative.

STAFF REPORTS

Development Application | 3747 10th Ave.

Council authorized the issuance of Development Variance Permit No. 107 for 3747 10th Avenue enabling a reduction in on-site parking.

Council further authorized issuance of Development Permit No. 21-13 enabling a renovation of the existing commercial unit on the property.

Development Application | 5019 Montrose St.

Council authorized the issuance of Development Variance Permit No. 112 granting variances to minimum parking, setbacks and parcel coverage to bring the existing building at 5019 Montrose Street into compliance and facilitating the issuance of Development Permit No. 21-15 for the construction of three new townhouse units.

Temporary Use Permit | 3665, 3675, 3689 4th Ave. Council directed staff to issue public notice with respect to an application for a Temporary Use Permit [TUP] on City Lands [3665, 3675, 3689 4th Ave.] for Transition House Use [Tiny Shelters].

Council will be asked to consider issuance of the TUP at its Regular meeting of September 26, 2022.

Grant Funding Opportunity

Council authorized staff to amend the 2022-2026 Financial Plan to allocate \$290,000 towards the Roger Creek Connector Trail Project in 2023 and directed staff to submit applications to the BC Active Transportation Infrastructure Fund and Natural Infrastructure Fund for respective portions of the proposed multi-modal Trail Project linking the Roger Creek and Scott Kenny trails.

Generational Investment and Transformation of Island Coastal Economic Trust [ICET]

Council directed staff to prepare a letter in support of ICET's application to the province requesting a generational investment of \$150 million to support and equip local communities with an enduring, sustainable trust that empowers collaboration through accountable decision-making for generations to come.

BYLAWS

"Official Community Plan Amendment No. 37 Bylaw No. 5046", "Zoning Text Amendment No. T31 Bylaw No. 5047" and "Zoning Map Amendment No. 48 Bylaw No. 5048" were read a third time. Prior to Council considering final adoption, the applicant is required to complete the design of off-site works, a storm water management plan, geotechnical report and site grading plan. The proposed bylaws upon adoption would enable a high-density, multifamily in-fill development at 4738 Athol Street.

On behalf of the Port Alberni Fire Department, Council proclaimed the week of October 9 – 15, 2022 as 'Fire Prevention Week' in the City of Port Alberni.
