#### **HOME OWNER GRANT**

The Province is now entirely responsible for the Home Owner Grant program (new or retro).

- All eligible home owners must apply directly to the Province by phone or online.
- The City of Port Alberni and Financial Institutions <u>cannot</u> accept Home Owner Grant applications.
- The program is centralized through the Province.
- All eligible home owners <u>must still apply by</u> <u>July 2, 2025</u>, in order to avoid late payment charges.
- All eligible home owners must <u>still apply each year.</u>

## PROPERTY TAX DEFERMENT

Property Tax Deferment is a low interest loan program that assists qualifying BC home owners (families with children and also those 55 or over) in paying the annual property taxes on their home. Please note: the Province's Property Tax Deferment program is now an online process.

### **HOW TO PAY YOUR PROPERTY TAXES**

There are five ways you can pay your taxes:

- 1. Online or through telephone banking;
- 2. At your bank or credit union (with your tax notice);
- 3. In person at City Hall 8:30 a.m. to 4:30 p.m., Monday to Friday, except statutory holidays;
- 4. By mail to the City of Port Alberni;
- 5. Through the secure 24-hour City Hall drop slot.


# YOUR MONEY AT WORK

Every year the city evaluates its revenue needs and expenses to ensure that it maintains a balanced budget that serves the needs of our growing community.


For 2025 your City of Port Alberni Council adopted a balanced budget with a new tax rate of 13.98 per cent for the average single-family home. This new tax rate translates into an additional \$29.51 per month — or about \$1 per day.

This tax rate increase will help with the continued provision of essential services, maintenance of our vital infrastructure, and supports our community's continued growth. A breakdown of the city's revenue sources and how those dollars are spent is outlined for you below.

Strategic Goal 1.3 - highest and best use of waterfront for active lifestyles

The City of Port Alberni has signed the Somass Lands master development agreement with Matthews West Developments Ltd., a private Canadian development company based in Squamish, BC.

The city and Matthews West recognize the importance of enhancing the natural environment through the master planning process and are committed to creating a development that fosters an active lifestyle at our waterfront. With this in mind, the agreement sets out that a minimum of 20 per cent of the Somass Lands will be reserved as public space/green space.

Strategic Goal 2.3 - encourage investment and sustainable growth

To help encourage investment and align our community's goals for resident and business attraction, the city partnered with Community Futures Alberni-Clayoquot to launch *Choose Port Alberni*, an investment and business attraction hub that provides news and information about how and why to invest in Port Alberni.

### Fostering a Complete Community



Strategic Goal 5.3 - a connected community with safe pathways and trails

The four kilometre Quay to Quay pathway is complete, and it is so wonderful to see how often it's being used. To help ensure the safety of users during the evening hours sections of the pathway have been lit. A total of 56 solar street lights are now in place. These lights take a charge during the daylight hours and at dusk are triggered to omit a soft glow that lights the pathway for its users, keeping the pathway accessible and its users safe and visible.
