BYLAW NO. 4995

A BYLAW TO AMEND THE OFFICIAL COMMUNITY PLAN
FOR THE CITY OF PORT ALBERNI

The Municipal Council of the City of Port Alberni in Open Meeting Assembled Enacts as follows:

1. Title

This Bylaw may be known and cited for all purposes as "**Official Community Plan Amendment No. 28 (5536 and 5546 Swallow Drive - Power), Bylaw No. 4995**".

2. Official Community Plan Map Amendment

2.1 **Schedule A (Land Use Map)** that forms an integral part of Official Community Plan Bylaw, No. 4602 is hereby amended to change the designation of Lot D, District Lot 10, Alberni District, PL EPP11441 (PID:028-647-092); and Lot E, District Lot 10, Alberni District, PL EPP11441 (PID:028-647-106), located at **5536 and 5546 Swallow Drive**, from 'Residential' to '**Multi-Family Residential**' as shown outlined in bold on Schedule "A" attached hereto and forming part of this bylaw.

2.2 **Schedule B (Development Permit Areas Map)** that forms an integral part of Official Community Plan Bylaw, No. 4602 is hereby amended to include Lot D, District Lot 10, Alberni District, PL EPP11441 (PID:028-647-092); and Lot E, District Lot 10, Alberni District, PL EPP11441 (PID:028-647-106), located at **5536 and 5546 Swallow Drive**, in **Development Permit Area No. 1 Multiple Family Residential**.
