#### SUBJECT: Parking Infraction Fines

#### <u>ISSUE</u>

To consider the input received from the public regarding the proposed increase in fines for parking ticket infractions.

#### BACKGROUND

City Council gave 1<sup>st</sup> reading to Traffic Regulation No. T1 (Parking Fines), Bylaw No. 4839 (see attached) on April 14, 2014. The bylaw proposes to increase the fine amounts for parking tickets. Before considering further readings of the bylaw, Council directed that public consultation be received on the proposed fine increases.

A two question public survey was open from May 2, 2014 to May 30, 2014 and was made available to the public primarily online. Letters were also sent to the Chamber of Commerce, businesses and property owners around the areas where the Commissionaires enforce parking regulations.

#### DISCUSSION

There were 29 respondents that accessed and answered the survey questions. There are two charts attached to the report showing the results of the survey. On the first question, 48% supported the increase in fines for time limit parking contraventions and 52% opposed the increase. On the second question, 45% supported the increase in fines for other parking contraventions and 55% opposed. The comments that were received with the survey are attached to this report.

The City of Port Alberni also received 7 written responses and 2 phone messages. The written responses are attached for information. These responses were 55% in support of increasing the fines and 45% opposed.

#### <u>Options</u>

1. City Council can proceed with further readings of Bylaw 4839 to increase the fines for parking tickets.

2. City Council can defeat Bylaw 4839 to keep the current fines for parking tickets.

Direction from Council is requested.





Mr. Smith,

I appreciate receiving your letter regarding the potential increase on parking fines in the City of Port Alberni and having a chance to voice my opinion.

First off I was wondering if you could tell me what this report on the potential to increase parking fines is costing/has cost the city. Please include person hours and their respective wages along with the cost of printing and mailing these letters.

Secondly, I would like to know the name(s) of the members of City Council who actually approved this study if it wasn't a unanimous decision

I was also wondering if you could tell me what the parking fine net revenue was for last year. I could be way off but it seems to me that the cost of this study is probably more than what the city took in last year

Now in the study it says that Port Alberni was compared to Nanaimo, Comox, Courtenay, Campbell River, Qualicum Beach and Parksville? Seriously? Last time I checked those cities actually had multiple businesses that attracted people into their restricted parking zones. Which of those cities was rated the worst place to live in Canada? Is it really fair to compare our downtown with any of theirs?

Probably the most disturbing word in you entire letter is "deterrent." Does the Council actually believe the City of Port Alberni should be deterring people from parking downtown? They meet at City Hall don't they? I believe before any rate increases should be considered perhaps it would be better to actually enforce the parking restrictions for more than a few hours, one or two times a week first and see how that goes.

My main fear is that this sounds like it would be something that would need to be announced to the public. That alone might shy people from coming to this side of town. If it weren't for the banks... I don't even want to think about what might happen. I have walked the entire restriction areas at different times of the day and I do believe something should be done.

Here are some suggestions:

Designated business parking stalls? I say this because I actually heard someone say that they were going to buy a new shirt at Cloud City and because there wasn't a parking stall right out front of the store he didn't stop.

Maybe make the 3rd Ave. corridor 1 hour only in addition to designated stalls? I see the Smoke Stack received 4, 20 minute stalls probably to appease them that the fact that the Steampunk put in that beautiful patio and actually classed-up the town. And seriously, there's one massive parking area, 2 relatively large and one large unofficial parking area all within very little walking distance of any business downtown. (maybe the city could take that gravel they used to block that small lane, replace it with a couple of concrete barriers and use the gravel to fill in the ponds and grade that gravel area?) I grew up here, moved away to various cities and came back. Port Albernians seem to be on another planet. I could walk from Kitsilano to downtown Vancouver in about the same time it would take me to drive and find a parking spot, and then once I did I'd have to pay for the privilege! Heaven forbid someone here should have to walk 50 metres.

I sure hope that Friday night 9pm parking restriction isn't enforced.

The block that the Swale Rock is on seems to be a bit of a problem, especially on weekends or if there's a festival of some sort. I've seen locals practically fight over parking spots so they could walk up the grassy hill to watch the Toy Run. Doesn't seem fair to the business owners there.

I also noticed that the parking stalls in front of the businesses such as the Doughnut Shop etc. are 3 hours. Maybe someone should ask them if they'd like those few stalls restricted to a shorter time so if someone actually wants to swing in there quickly for something they could do so.

Locals should know better. I don't know how advanced the parking fine system is here but maybe the city could instill a one time only "get out of jail free card" to visitors? By license plate perhaps? Maybe make it a promotional thing. Instead of mailing them a fine you could mail them a thank you note?

I don't know. Other than your salary I don't envy your position. Finding money to maintain the city's infrastructure must be like squeezing blood from a stone but this parking thing is ridiculous. I'm kind of disgusted it was even considered.

#### **BYLAW NO. 4839**

#### A BYLAW TO AMEND CITY OF PORT ALBERNI TRAFFIC REGULATION BYLAW, 2009 BYLAW NO. 4670

The Municipal Council of the City of Port Alberni in Open Meeting Assembled Enacts as follows:

### <u>Title</u>

1. This Bylaw may be known and cited for all purposes as "Traffic Regulation No. T1 (Parking Fines), Bylaw No. 4839".

#### Text Amendment

- 2. Port Alberni Traffic Regulation Bylaw No. 4670 is hereby amended as follows:
  - 2.1. By deleting the following from Section 10 Penalties:
    - "10.2 The minimum penalty for the contravention of any section of this bylaw shall be a fine of thirty (\$30.00) dollars and in default of payment to a term of imprisonment not exceeding one month.
    - 10.5. (a) The voluntary penalty for any contravention of Section 4.3(a) shall be:
      - (i) Ten (\$10.00) dollars and fifty cents if paid within 48 hours from the issue of the parking offence notice;
      - (ii) Twenty (\$20.00) dollars if paid after 48 hours but within 10 days from the issue of the parking offence;
      - (iii) Thirty (\$30.00) dollars if paid after 10 days from the issue of the parking offence notice.
      - (b) The voluntary penalty for any contravention of any other section of Section 4 shall be:
        - (i) Ten (\$10.00) dollars if paid within 48 hours from the issue of the parking offence notice;
        - (ii) Twenty (\$20.00) dollars if paid after 48 hours but within 10 days from the issue of the parking offence;
        - (iii) Thirty (\$30.00) dollars if paid after 10 days from the issue of the parking offence notice.
      - (c) The voluntary penalty for any contravention of Section 4, time limit shall be:
        - (i) Five (\$5.00) dollars and fifty cents if paid within 48 hours from the issue of the parking offence notice;
        - (ii) Ten (\$10.00) dollars if paid after 48 hours but within 10 days from the issue of the parking offence;
        - (iii) Thirty (\$30.00) dollars if paid after 10 days from the issue of the parking offence notice."

- 2.2. By adding the following to Section 10 Penalties:
  - "10.2 The minimum penalty for the contravention of any section of this bylaw shall be a fine of sixty (\$60.00) dollars and in default of payment to a term of imprisonment not exceeding one month.
  - 10.5. (a) The voluntary penalty for any contravention of Section 4, time limit shall be:
    - (i) Ten (\$10.00) dollars and fifty cents if paid within 48 hours from the issue of the parking offence notice;
    - (ii) Twenty (\$20.00) dollars if paid after 48 hours but within 10 days from the issue of the parking offence;
    - (iii) Fifty (\$50.00) dollars if paid after 10 days from the issue of the parking offence notice.
    - (b) The voluntary penalty for any contravention of any other section of Section 4 shall be:
      - (i) Fifteen (\$15.00) dollars if paid within 48 hours from the issue of the parking offence notice;
      - (ii) Twenty five (\$25.00) dollars if paid after 48 hours but within 10 days from the issue of the parking offence;
      - (iii) Sixty (\$60.00) dollars if paid after 10 days from the issue of the parking offence notice."
