## **ELECTOR REGISTRATION**

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day;
- Canadian citizen;
- Resident of BC for at least 6 months immediately preceding the day of registration;
- Resident of OR registered owner of real property in the City of Port Alberni for at least 30 days immediately preceding the day of registration, and;
- Not disqualified under the *Local Government Act* or any enactment from voting in an election or otherwise disqualified by law.

**Resident Electors must produce 2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must provide both residency and identity.

**Non-resident property electors must produce 2 pieces of identification** (at least one with a signature) to prove identify, **proof** that they are entitled to register in relation to the property, and if there is more than one owner of the property, **written consent** from the majority of the property owners.
